**LOCATION:** ODESSA TERRY POOL, Hockanum Park, High Street, East Hartford

**FACILITY:** 8-lane, 50-meter pool with a depth of 10+ feet at the blocks. Colorado Timing System with touch pads for 100 meters, or more, will be used. Seating is outside the fence. Bring your own chairs.

**SCHEDULE:** Morning: All swimmers 7:30 AM Warm-up; 8:30 AM Start

**ELIGIBILITY:** Swimmers and coaches must be 2003 registered members of USA Swimming. Coaches must display credentials at all times.

**RULES:** Current USA Swimming rules will govern. All events will be timed Finals. CSI scratch procedures are in effect.

**ENTRIES:** Swimmers may enter up to four (4) individual events per day exclusive of relays. Please circle fourth event. Teams are encouraged to submit their entries on an IBM PC diskette using the LSA Swim Team program or Hytek program. Meet entries must be submitted on the official entry form or a computer generated facsimile. Your entry will not be considered final until we receive your entry fee and hard copy by mail.

Mail your entry (both disk and paper copy) to Mike Jackwin at the address located on the cover page of this meet announcement. Please send your original entry, not a photocopy. The phone number of a club official must be included on the form as well as club mailing address. Teams submitting their entries on diskettes will receive a copy of the results on diskette for their records.

If any of your swimmers are swimming the meet UNATTACHED, please mark this clearly in RED alongside the swimmer's name on the entry sheet. NT entries are strongly discouraged. Please estimate swimmer's times, if necessary, for seeding purposes. ALL TIMES MUST BE IN METERS.

## **ENTRY FEES:**

Splash Fees: \$3/individual event \$6/relay

Manual entry fee: If you submit hand entered entries a \$1.00 charge will be added to each swimmer, over 5 and a limit of 50.

**ENTRY DEADLINE:** Connecticut team entries that are received by June 14, 2003, will be entered on a first come, first serve basis. After that date, CT and out-of-state entries will be accepted in order received, space permitting. Formal team entry date is determined by the date of entry hard copy and entry fee receipt by host team.

**OVER-SUBSCRIPTION:** In the event of oversubscription:

1st: relays will be cut

2nd: 4th event will be cut

The sponsor reserves the right to make adjustments based on the time study and other factors. Teams will be notified of any changes no later than Monday, June 23, 2003.

**AWARDS:** Ribbons will be awarded for 1st - 8th places for individual events and 1st - 3rd for relays. Traditional age groups 10/U, 11/12, 13/14 and 15/O. Heat winners will receive an award.

**TIMERS:** Swim teams will be required to supply timers based on their entry for the duration of the meet. Teams submitting a list of officials willing to work will be credited accordingly.

**SCRATCHES** Scratch sheets will be provided in coaches' packets. These sheets **MUST** be returned 40 minutes before the session begins with scratched swimmers clearly identified.

**CT SCRATCH PROTOCOL** In all events, after the heats have been seeded, any swimmer who fails to compete in an individual event in which he has been entered and from which he has not been scratched shall be barred from competing in his next individual event. Exceptions for failure to compete: No penalty shall apply for failure to compete if: 1) The referee is notified in the event of injury or illness and accepts the proof thereof. 2) If it is determined by the Referee that failure to compete is caused by circumstances beyond the control of the swimmer.

**WARM-UP:** Connecticut Swimming, Inc. warm-up guidelines will be observed. The meet manager reserves the right to assign general warm-ups by team rather than age or sex, if the size of the entry and considerations of safety so require. Details and lane assignments will be made available in coaches' packets.

**RESULTS:** Electronic results will be e-mailed to attending teams if an e-mail address is provided. Paper results will be sent to participating clubs upon request.

**REFRESHMENTS:** Food, snacks, beverages and programs will be available for purchase.

**DIRECTIONS:** I-91 North, take Exit 25 (Route 3). Take first exit after bridge (Glastonbury). Turn left at first traffic light. Turn left onto Main Street (north). Continue north on Main Street past large shopping center to first light. Turn left onto Broad Street. Broad Street becomes High Street at Naubuc Avenue. Continue 300 yards. Pool is on right.

From Route 2 West, take Hebron Avenue exit. At exit proceed to Main Street (Glastonbury). Turn right onto Main Street (north) and follow directions above.

I-84 East or West, take exit to CT Route 2 East to East Hartford. Take High Street exit. At bottom of the ramp, turn right. Proceed onto High Street for 300 yards. Pool is on the left.

**PARKING: NO ON STREET PARKING IS ALLOWED. IF POOL PARKING LOT IS FULL, PARK IN THE SCHOOL LOT.**
