Parking: No parking will be permitted on the street directly in front of the athletic center or on any practice field. Wesleyan will tow all illegally parked cars. Please plan to park in the lot next to the tennis courts on Vine Street or the new lot across from the Athletic Center.

Handicap Access: Use main entrance. Spectator area is accessible from the main entrance. Elevator in lobby will take swimmers to the pool deck.

Events: The 1500 meter free will be swum fastest to slowest. The 400 meter free will be swum slowest to fastest, girls first then boys. All 11 & 12 year old events will be restricted to swimmers that have either reached the age of 11 or will reach the age of 11 prior to the CT. Age Group Championship meet.

Eligibility: Only 2005 USA Swimming registered swimmers are eligible and must be registered prior to the date of the meet. This meet is closed to any swimmers not registered with CT. Swimmer Inc. ***Priority will be given to swimmers that have not made a championship cut-off time. All swimmers must supply their own timer and lap counter.***

USA Swimming rules will govern the meet. Coaches will be required to display their USA Swimming registration card in order to be on deck.

Entry Fee: \$4.00 for the 11/12 year old events, and the 400 meter events. \$6.00 per 1500 meter event. Please make checks out to *Hopkins*.

Entry Deadline: Priority will be given to entries received prior to the meet date. The remaining spots will be filled with deck entries.

Awards: None

Information: Please remember that we are guests of Wesleyan University and therefore all swimmers, coaches, and spectators are expected to treat the facility with respect. It is the responsibility of each team to supervise their swimmers when they are not swimming. Any violations of the Connecticut Swimming Code of Conduct will result in the expulsion of a swimmer and/or team.

Directions:

From the South: From I-91 North or the Merritt Parkway, follow signs to 66 East. (initially I-691) and proceed to Middletown. At light (by graveyard) turn right onto Vine Street. At next light, turn right and the pool is on your left.

From the North: Take I-91 South to exit 22S (Rte. 9 South) to exit 15 (Washington Street). At the 5th light make a right onto Vine Street. At light turn right. The pool is on your left.
