Name: Madison Mile

2 Events: A: 1 Mile Open Water Championship in Long Island Sound (Ages 11 +)
B: Mini Mile Open Water Swim (approx 500yds) (Ages 9-12)

Entry Fee: \$20 Pre-entry for all USA Swimming members
\$25 race day entry
\$25 Pre-entry for USMS members, one day USMS members \$30
\$30 race day entry USMS members, one day USMS members \$35

Age Limits: A: One Mile Championship (Minimum age of 11)
B: Mini Mile (Minimum age of 9 – Max age of 12)

Awards: USA Swimmers: Top 3 for both Male and Female (11-12,13-14,15-16,
17-18, 19+) for 1 Mile Championship. Top 3 for both Male and Female (9-10,
11-12) for Mini Mile
USMS Swimmers: Top 3 in each age group for both Male and Female
Wetsuit Division: Top overall Male and Female, not eligible for age group.

Rules: Current USMS and USA Swimming open water swimming rules will govern this event. A one-hour cutoff time will be strictly enforced. Wetsuits are permitted but swimmers are ineligible for age group awards, only eligible for wetsuit division awards.

Timing: Electronic CHAMPIONCHIP TIMING will be used. Each swimmer will wear an electronic timing chip secured by an ankle bracelet to automatically record their time as they run across the finish line. The timing chip must be returned or a \$30 charged will be assessed to the swimmer for failing to return the chip.

Location: Surf Club, Madison, CT (Madison Town Beach)

Facility Description: Large club house with bathroom and registration facilities.
Approximately 1/3 mile of beach. Minimal currents in this location.

Entry Format: Open to all USA registered swimmers and USMS masters swimmers.
Unattached swimmers over age 19 must pay 1-day membership fee for USMS to obtain insurance coverage. Unattached swimmers under age 19 are not permitted.

How to enter: USA Swimming athletes can enter in three different ways:

TEAM ENTRY: USA Swimming clubs can enter as a group by submitting a print-out of all entrants (with name, age and USA #) using LSA or Hytek software. Meet files are posted on ctswim.org. Mail the print-out and club check to: Force 5 Sports, 17 Yankee Glen Dr., Madison, CT 06443 by June 21st. If you enter in this manner you do not need to fill out separate application forms for each swimmer. Please no discs or emails.

INDIVIDUAL ONLINE ENTRY: Each swimmer could also register themselves online through www.active.com.

INDIVIDUAL MAIL ENTRY: Each swimmer can also register individually by completing the event application and sending it via regular mail. Photo copies of the application form are permitted.
