Swimmer Eligibility: Open to all 2007 registered members of USA Swimming. Age Group will be determined by age as of July 14, 2007. There are no cut-off times.

Coach Eligibility: All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

Entry Limitations: Swimmers may compete in 1 individual event.

Cut Protocol/Changes: The meet will be limited to one heat per event. If the meet is oversubscribed, entries will be accepted based on the date/time the email entries are received. The Meet Referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet, with prior approval from Program Operations. If any changes are necessary, teams will be notified by July 13.
