**Entry Deadline:** Friday, April 13, 2007. Email entries accepted. Snail mail entries to the address of the entry chair. Connecticut teams will be entered in the meet first, acceptance being determined by date/time entries are received. Out of state entries will be accepted only after CT entries have been accepted, based on session availability.

**Entries:** Swimmers are limited to 4 events per session. Swimmers must be registered members of USA Swimming. Age is determined as of April 21, 2007. All entries are to be submitted using LCM times. NTs are discouraged. All teams are encouraged to send entries using email, using Hy-Tek or LSA software. Please submit a paper copy of the entry along with the entry. The paper copy will be considered the official entry in the event of discrepancies. Entries submitted without electronic files will be assessed \$1.00 per swimmer. Payment must be mailed to the meet director, postmarked no later than Saturday, April 14.

**Fees:** \$4.25 per event. Checks payable to Woodbridge Aquatic Club.

**Coach Eligibility:** All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of the swim meet, and must have this with them at all times while on deck.

**Awards:** No awards.

**Work Assignments:** Teams will be asked to supply timers in relationship to the size of their entry. Assignments are for the duration of each session. Officials from other teams are encouraged to work the meet.

**Concessions:** There will be no food concessions.

**Cut Protocol:** If a session is over subscribed first 7/Us, and then all fourth events will be cut. If the time line still exceeds four hours teams will be cut based on date of receipt.

**Directions:** Merritt Parkway to Exit 59. Turn south to the first traffic light and left onto Whalley Ave. Go 3.7 miles to York Ave. Turn left on York to the first light. Turn left. Yale's Payne-Whitney Gymnasium is straight ahead.

From I-95, take the Route 34 exit, turn right at the first light onto York, and follow the above directions.
