Teams will be assigned lanes for warm-up based on the size of their entry. No diving will be permitted during the general warm-up period.

Eligibility: Open to all 2008 Connecticut registered swimmers of USA Swimming. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

Entries: All entries must be submitted on Hy-Tek disc or other SDIF. Please include a hard copy of the entries. Also, please list the club official, telephone number and mailing address so any changes to the meet can be communicated to everyone. Use short course times for seeding. Please estimate times in events that swimmers have not previously raced in competition. Relays must be entered with seed times. If any of your swimmers are swimming the meet Unattached, please mark UNAT clearly in RED along side of the swimmer's name on the entry sheet.

Should the meet be oversubscribed, teams whose entries are received after the meet has been filled will be returned. Should we get to this situation a notice will be posted on HMST.org that the meet is full. An email will be sent upon receipt of a team entry notifying them of the status of their acceptance to the meet.

In order for a swimmer to be considered for the “Quadrathon” awards he/she must complete all four individual events legally.

The meet referee reserves the right to make any adjustments to the provisions of the meet announcement necessary to ensure the fair and efficient running of the meet. All changes are subject to approval by CSI Program Operations.

Deadline: Entries must be received no later than 6:00pm on Tuesday, May 20, 2008. An entry is considered received and accepted when the entry and payment has been received.

Timers: Back up timers will be requested based on the size of a team’s entry.

Timing System: Manual timing will be used for this meet.

Officials: Please submit the names of any officials willing to work the meet to the referee listed below. Teams that notify us of officials willing to work the meet by May 23, will receive credit on their timing assignments.

Information: It is the responsibility of each team to provide supervision for the swimmers and siblings when they are not on the pool deck. Any violations of the rules of sportsmanship and common courtesy could result in the expulsion of a swimmer and/or team from the meet. Cell phones with the ability to take photos will not be permitted in the locker rooms.

Directions:*From Rte. 15 (Wilbur Cross Parkway, Exit 59, South, from Hartford):* At the end of the exit ramp ,turn right. Rte. 63 (Amity Road) and Rte. 69 (Litchfield Turnpike) merge to form Whalley Ave. Approximately $\frac{3}{4}$ of a mile from that intersection, turn right onto Rte. 122 (Dayton Street). After traveling one block, follow Rte. 122 through the traffic signal onto Forest Road. The Hopkins School driveway is on the right immediately after the next traffic signal.

From Rte. 34 or 15 (Wilbur Cross Parkway, Exit 57 North, from NYC): From Rte. 15, take Rte. 34 (Derby Turnpike) east for 2-1/2 miles, turn left onto Rte. 122 (Forest Road). Hopkins is on the left after approximately $\frac{1}{2}$ mile.

From I-91 or I-95 North (New London – Hartford): Exit onto the Oak Street Connector-Downtown Rte. 34 (which is Exit #1 on I-91 and Exit #47 on I-95). Proceed to the end of the connector and then exit straight ahead onto the parallel Frontage Road (Rte. 34). Continue on this road about a mile until you reach the Boulevard. Take a right and get into the far left lane. At the light take a left – all the while remaining on Rte. 34. Continue until you come to Rte. 122 (Forest Road). Take a right and Hopkins will be on the left after traveling about $\frac{1}{2}$ mile.

From Rte. 95 (North from NYC): Use Exit #43 (Rte. 122, Campbell Ave. West Haven). Turn left at the end of the ramp. Follow Rte. 122 for 2 miles across both Rte. 1 (Boston Post Road) and Rte. 34 (Derby Turnpike), at which point it becomes Forest Road. Hopkins is on the left about $\frac{1}{2}$ mile ahead.
