Eligibility: All swimmers must be 2002 registered members of USA Swimming. Age group will be determined by age as of November 24, 2002. There are no cut-off times.
 All coaches must be current members of USA Swimming, and must display their credentials on deck.

Fees: Splash fees: Individual events - \$3.00 per event. Relays - \$6.00 per event.
 Make checks payable to AQUABEARS. **Only 1 check per team.**

Entries: Swimmers may compete in all events. Submit swimmers' best short course times for seeding. If possible, please submit entries on diskette using the LSA Swim Team Program or SDIF compatible software. If you submit non-computer entries for more than 5 swimmers, a \$1 charge, per swimmer, must be added to your fees. **The attached entry summary sheet must be submitted.**

Deadline: Entries must be received by 6:00 P.M. on November 12, 2002. If the meet is oversubscribed, entries will be accepted based on the date/time the entries are received, and relays will be cut before individual events. Per CSI, "Formal team entry date is determined by the date that both the hard copy and entry fees are received by the host team." The Meet Director reserves the right to combine sessions if the meet is undersubscribed, or make other changes, subject to the approval of CSI Program Operations. If changes are necessary, teams will be notified by 11/18.

Directions: From south of Suffield:

Take I-91 to Exit 38 - Poquonock. At end of ramp, turn right onto Rt. 75 North. Follow Rt. 75 North through Windsor Locks and into Suffield (about 8 miles). In the center of Suffield you will pass through two lights that are twenty yards apart. Suffield Academy is immediately on the left after the second light. The pool is at the bottom of the hill on the left.
