ELIGIBILITY: Swimmers must be 2002 registered members of
Connecticut/USA Swimming

FEES: Splash fees \$3.00, per individual event. Please make checks payable to
“OAK”

ENTRIES: Swimmers may enter and compete in four individual events per day. If a session is over-subscribed, swimmers will be limited to three events. If the meet remains oversubscribed, further cuts will be made based on the order in which entries are received. If a swimmer is entered in four events, please circle the event from which they wish to be scratched if the meet is over-subscribed.

Teams are encouraged to submit their entry on disk in SDIF (LSA SwimTeam). **Any team entering more than 8 swimmers that fails to submit a disk must pay a surcharge of \$3 per swimmer.** Please be sure to include a paper printout with your disk. Mark unattached swimmers in RED on the entry form. Be sure to include the phone number of a club official and a mailing address for results.

All entries by Connecticut teams must be received by October 21, 2002. If you use overnight mail or Federal Express, please be certain to indicate that no signature is required for delivery. Mail entry to Meet Director (listed above).

Sessions will be limited to four hours of competition. Teams will be notified of cuts affecting their swimmers as soon as possible and no later than Tuesday, October 29th. Paper Meet Results will be sent upon request.

WARM-UPS: Connecticut Swimming guidelines will be observed at all sessions. Warm-up assignments will be made by team rather than gender.

10 & Under and 13/14 in the morning and 11/12 and 15 & Over in the afternoon.

SCRATCHES: Coaches will receive a list of their swimmers and the events in which they are entered. All scratches due 40 minutes before the start of the meet. Swimmers who fail to compete in individual events in which they have been entered and from which they have not been scratched will be barred from their next event.

Coaches must show current USA Swimming card prior to receiving scratch sheets.

AWARDS: Ribbons will be presented through sixth place in each age group. Ribbons for relays will be 1st-3rd places.

REFRESHMENTS: Food and beverages will be available throughout the meet.

DIRECTIONS: Interstate 91 North. Exit 42 – take left at end of ramp – at 3rd traffic light take left onto Elm Street. At 3rd traffic light take left onto South Elm Street. High School entrance on left after church.
