Facility/Pool Description	6 lane, 25-yard pool with non-turbulent lane lines. Adequate seating and parking is available. Spectator seating capacity is 150. Handicap accessibility is available for participants and spectators through the Men's and Woman's locker rooms. Once out on the swim deck, a participant will be able to join his/her team. Handicap spectators will be able to view the meet from in front of the spectator stands.

Entry Deadline:	Entries must be received by Friday, November 26, 2004. Formal team entry is determined by the date of receipt of the entry hard copy and entry fee by the host team. No changes may be made after the entry is received. Any entry that is received after November 26, 2004 will be returned. Teams whose entry cannot be accepted will be notified as soon as the meet is full. Be aware the meet may close prior to the deadline. The meet management reserves the right to cut relays, limit heats, adjust warm-up and/or start times subject to the approval of Connecticut Swimming program operations.
Entry Format:	All events will be swam as timed finals and will be seeded according the swimmers best SCY times. "No Time" entries are discouraged. All swimmers entered in relays must be listed on the entry sheet. Teams are encouraged to submit their entries on a Windows format disc. Meet entries may be submitted on the official entry form or a computer-generated facsimile. An original paper copy of the entry must accompany all entries on disc. E-mailed entries are not considered official until we receive your check. Mail your entry to the Entry Chairperson listed above. If you send you entry by express mail, please sign the waiver so that the package will be delivered even if no one is there to sign for it. Please send your original entry, not a photocopy. The phone number (and where possible, a fax

	number and/or e-mail address) of a club official must be included on the form as well as a club mailing address.
Entry Fee:	Individual events are \$3.00 each; relays are \$6.00 each. Manual Entry Fee: for teams submitting paper entries without disc or e-mail entry files, a \$1.00 charge will be added to each swimmers over 5, with a maximum fee of \$50.00 per team.
Entry Limitations:	All participants must be 2004-2005 USA Swimming registered. This meet is Closed to non-CSI swimmers. USA Swimming Rules will govern the meet. Fly-over starts may be used in the case of over-subscription as determined by the meet referee and the meet manager, with proper protocol training of Officials from Officials Chairman. Swimmers may swim a maximum of 4 individual events per day. In the event of over-subscription, 7/U swimmers will be cut, then relays and third 4 th event must be marked to delete.

Starting Time:	12/Under – 9:00AM 13/O – 2:30PM
Scratch Sheets:	Scratch sheets must be completed and returned to the computer operators within 30 minutes of the beginning of warm-ups.
Refreshments:	Food and beverage will be available during the meet, however, food will not be allowed in any other areas of the building other than the cafeteria.
Directions:	From I-95: Take Route 25 North to Daniel's Farm Road. Turn Right onto Daniel's Farm Road and go approximately ½ mile. Turn Right at Hillcrest Middle School. From Merritt Parkway: Take exit 49N (Route 25N) to Daniel's Farm Road (exit 9). Turn Right onto Daniel's Farm Road and go approximately ½ mile. Turn Right at Hillcrest Middle School.
Credentials:	All coaches and officials must show their valid USA membership cards for admittance to the pool deck. Coaches without coach membership cards will not be allowed on deck.
Parking Advisory:	Parking must be in marked spaces only. There is extra parking behind the school building.
Timers:	All teams will be required to provide timers based on the size of the entry. Pisces welcomes anyone who wishes to assist in officiating during this meet. Officials, please contact Meet Manager.
Distance Events:	Swimmers must supply their own timers and lap counters for the 500Y Free event.
