This event for the evening will be limited to 10 heats, alternating girls and boys, fastest to slowest. In case of over-subscription, 11 & 12 year old swimmers will be cut first by seedtime. Teams will be notified of cuts no later than Monday, November 7, 2005.

ELIGIBILITY: This is an event for 11 & older Connecticut swimmers only. Swimmers and coaches must be 2005 or 2006 registered members of USA Swimming. Age will be determined by age as of November 10, 2005. All coaches must present a valid USA Swimming Coach Card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

ENTRIES: Please submit swimmers best short course or estimated times for seeding. Entries must be sent in on standard Connecticut Swimming entry sheets or a computer generated facsimile. Clubs which use the LSA Swim Team Program, or SDIF compatible software may send entry information on a 3.5" diskette but must include a printout of the entry as well. Unattached swimmers must be clearly identified. E-mail entries may be mailed to mjackwin@comcast.net but the entry will not be considered accepted until hard copy and payment has been received.

DEADLINE: Entries must be received by November 1, 2005 and will be entered on a first come first serve basis. Teams will be notified by Monday, November 7, 2005 of any cuts or scheduling changes. WARM UP PROCEDURE: Connecticut Swimming, Inc. warm up guidelines will be observed. The meet manager reserves the right to assign general warm-ups by team rather than by age or sex, if the size of the entry and considerations of safety so require. Details and lane assignments will be made available in coach's packets.

DIRECTIONS: FROM SOUTH: I-91 North: take exit 25, route 3. Keep to left and take Route 2 to East Hartford, exit 5A to Main Street. Turn right at first light at Brewer Street. Turn left at 2nd light and school will be approximately ½ mile on the left.

FROM NORTH AND WEST: Take I-84 East, to Roberts Street Exit. At end of exit take a right and an immediate left onto Silver Lane. Turn right at Forbes Street (5th light). School will be on right approximately ¼ mile.

FROM EAST: Take I-84 West to I-384 East. Exit Spencer Street, Silver Lane, Turn right onto Spencer Street. (Turns into Silver Lane at East Hartford town line). Turn left onto Forbes St. School will be approximately ½ mile.
