FACILITY: 6 lane, 25 yard pool with a depth of 12 feet at the starting blocks.
Electronic Timing. Ample deck space for swimmers and spectator seating for 300.

ELIGIBILITY: Swimmers must be 2006 registered members of USA Swimming. All coaches must present a valid USA Swimming coach Card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

FEES: \$4.00 per individual event; \$10.00 per 1000/1650 Freestyle. Please make all checks payable to Woodbridge Aquatic Club.

AWARDS: No awards at this meet.

ENTRIES: Swimmers may enter and compete in five individual events per day, not including time trials. Entries will be accepted based on the order in which they arrive. Connecticut teams whose entries are received by Tuesday, February 7 will receive priority before out of state entries are accepted. Sessions in the meet will each close once four hours of competition is assured. **All entries must be received by Wednesday, February 8, 2006.** Teams submitting entries after sessions are filled will immediately be notified upon receipt of entry.

Teams are encouraged to submit their entry on disk (either LSA, Hy-tek other SDIF program). **Any team entering more than 5 swimmers that fails to submit a disk must pay a surcharge of \$3**

per swimmer. Please be sure to include a paper printout with your disk, or use a CSI entry form. Mark unattached swimmers in RED on the entry form. Be sure to include the phone number of a club official and a mailing address for results. If you use overnight mail or Federal Express, please waive signature for delivery. The meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet, with approval by Program Operations.

DISTANCE FREESTYLE EVENTS: Swimmers must provide their own timer and counter. Heats will run fastest to slowest, alternating women and men.

TIME TRIALS: Time Trials will be offered at the end of each morning session and/or prior to the afternoon distance freestyles, if time permits. Swimmers must provide their own timer. Time trial fees are \$4.00 per event.

REFRESHMENTS: Food and beverages will be available throughout the meet.

DIRECTIONS:

From the east or west: I-95 to I-91 North. Take Exit 3 (Trumbull Street). Go straight ahead on Trumbull to Prospect Street. Turn right and follow Prospect Street about 1 ¼ mile to Huntington Street. Turn right onto Huntington Street and the Athletic Center is just ahead on the left.

From the north: Follow the Wilbur Cross Parkway (Route 15) to Exit 61 (Whitney Ave.) Turn right and follow Whitney Ave. about 4 miles to Ogden Street. Turn right onto Ogden and proceed to Prospect Street. Turn right onto Prospect Street and take a left onto Huntington Street. The Athletic Center is just ahead on the left.

Handicapped/Elderly Accessibility: Handicapped parking and ramped access to the pool are located at the main lobby entrance of the facility. An area has been set aside on the pool deck for limited handicapped seating. Handicapped bathrooms are available in both the men and women locker rooms.
