Eligibility: USA Swimming Rules will govern this meet. Coaches will be required to show their up to date USA Swimming registration card before picking up their team packet and scratch sheets. All coaches must present a valid USA Swimming coach Card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

Entry Dates: Entries must be received by 6:00 pm, January 7, 2007. Entries are accepted on a first come, first served basis. Connecticut Swimming teams whose entries are received by December 31, 2006 will be entered in the meet first. After that date, CT Swimming and out-of-state teams will be accepted based on dates/time the entries (including check) are received until the meet is full. Formal team entry date is determined by the date of entry hard copy and entry fee receipt by host team. If entries are sent via overnight mail, please waive the "signature required". The meet manager and meet referee reserve the right to combine sessions, or adjust start times based on the number of entries received, with approval from CSI Program Operations. Teams will be notified by Saturday, January 14, 2006 in the case of changes.

Entry Limitations: In order to be included in the Pentathlon scoring, a swimmer must compete in the 5 events for their age group. A swimmer may enter and swim fewer events for time, but will not be included in

the scoring for awards. The freestyle event is defined as a stroke other than butterfly, breast or back. There are no cut off times for this meet. "No times" are discouraged. Please attempt to enter every swimmer with a time for their events. The meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet. All changes are subject to approval by CSI Program Operations. Connecticut Swimming warm-up procedures will be used. The Meet manager reserves the right to assign general warm-up by team rather than age or sex, if the size of the entry and considerations of safety so require.

Entry Format: Open to all 2007 USA swimming registered swimmers. Please make sure to include their up-to-date registration numbers and age of all swimmers with the entry. Age group will be determined by age as of, January 21, 2007. Times must be submitted in **SHORT COURSE YARD TIMES**. Teams are encouraged to submit entries either via e-mail to **scp666@comcast.net**, if attached in a zip file or a computer disk using HYTEK swim team program or any other program in SDIF. An original computer generated copy of the entry with all pertinent team information and entry totals must be included. The name, phone number, email address and mailing address of a club contact must be included with the entry. Any computer-generated entry may be submitted by either e-mail or on a disk. Official CSI entry form must be submitted in lieu of a disk. Unattached swimmers must be clearly indicated in red alongside the swimmer's name. Information contained on the original computer generated paper copy will be considered the official document of entry and supersedes any information contained on electronic disk or file with respect to resolution of errors/discrepancies. Meet results will be provided on disk to any team submitting its entries on disk. Teams with 10 or more swimmers will be assessed \$1 per swimmer if the entry is submitted on paper, without a disk. Entry chairpersons are encouraged to provide an e-mail address along with their phone number.

Work Assignments: Teams will be required to supply timers in proportion to the size of their entry. Please note that timers are required for the whole session. Scratches: Coaches will receive scratch sheets at the beginning of the sessions. Scratch sheets must be returned within 20 minutes after the start of warm-ups.

Directions:

From south of Suffield: Take I-91 to Exit 38. Turn right onto RT 75(North) and continue through Windsor Locks, into Suffield (approx. 8 miles). In the center of Suffield you will pass through two lights that are twenty yards apart. Suffield Academy is immediately on the left after the second light, at then end of the town green. The pool is at the bottom of the hill, on your left.
