### Pool Facility:

- 6 lane 25 yard pool. Manual Timing.
- Pool is Handicap Accessible. If you need help, contact any member of the meet committee.
- Limited seating and parking is available.
- Concession area is also available.

### Eligibility:

- All swimmers must be 2006 or 2007 registered members of USA Swimming.
- Age is determined by the swimmer's age as of November 17, 2006.
- All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck

### Events:

- All events will be timed finals.
- USA Swimming rules will govern the meet.
- Meet management reserves the right to limit heats, adjust warm-up and/or start times or make other changes to ensure a quality meet. All changes are subject to approval by CSI Program Operations.
- Entries are to be submitted in best yard times.
- Swimmers can enter and compete in all five events.
- The meet will be kept to a one hour and 15 minute session as we have in the past.

### Entry Fee:

- All individual events are \$4.00 each. All Relays are \$8 each.
- Make all checks payable to **NAC**
- Mail the check with entry form to the entry chair above. If you send your entry by express mail, please sign the waiver so that the package will be delivered even if no one is there to sign for it.

- There will be a \$1.00 surcharge for each swimmer; for five or more hand entered entries.

**Entry Deadline:**

- Entries from Connecticut are due Friday, November 3, 2006 and will be entered first.
- Formal entry is determined by the date of receipt of the hard copy of the entry and the entry fee.

**Cut Procedure:**

- Teams will be notified immediately after the November 3, 2006 deadline.

**Times of the meet:**

Meet management reserves the right to limit heats and adjust warm up and/or start times, with approval from Program Operations. The meet must be run in 75 minutes.

**Entry Form:**

- Open to all 2006 or 2007 USA Swimming registered swimmers.
- Entry should include USA registration number and age of all swimmers.
- Please identify all unattached swimmers with red ink.
- Entries must be on IBM disc using Hy-Tek, LSA, or other SDIF format, but must be accompanied by a computer printout. Include on the entry form, the team name, address, and telephone of the head coach and/or club official responsible for the team's entry.
