FACILITY/POOL DESCRIPTION: 10 Lanes, 25 yard pool. The sponsor reserves the right to adjust to 8 lanes if deemed warranted by the projected time line. The timing system will be Daktronics System with touch pads. There is ample deck space for swimmers and limited spectator seating. Swimmers may bring deck chairs and we encourage the public to bring deck chairs as well. Overflow parking available across the street at Cheshire High School. The facility is accessible to the disabled. Please contact the Meet Manager with questions.

ENTRY DEADLINE: Entries will be accepted on a first-come first-served basis. Date of receipt is based on Hard Copy and Payment received by Entry Chair. Deadline for CT teams is Tuesday, January 8, 2008 at 6:00 pm. If there is still room in the meet, Out of State teams will have until Friday, January 11, 2008 at 6:00 pm or until the meet is full.

ENTRY FORMAT: Teams may email entry to entry chair or submit entries on disk using LSA, Hy-Tek or SDIF software. A paper copy must be sent either way with check. Entries must include name, phone number, email & mailing address of team contact. Also include meet entry fee report for Hy-Tek entries. Unofficial swimmers must be clearly marked in RED. NT

entries are **STRONGLY DISCOURAGED**. Entry times should be in Short Course Yards. If sent overnight mail, please sign "waiver of signature". Entries will be accepted on a first-come first-served basis.

**SWIMMER
ELIGIBILITY:**

Swimmers must be 2008 registered members of USA Swimming.

**COACH
ELIGIBILITY:**

Coaches must be 2008 registered members of USA Swimming. All coaches must present a valid USA Swimming Coach Card to the Meet Director prior to commencement of any sanctioned swim meet and must have this card with them while on deck.

**ENTRY
LIMITATIONS:**

Swimmers may compete in 2 events.

**CUT
PROTOCOL:**

Entries will be received until the meet is full. Any teams that get cut from the meet will be notified by the Monday, January 14, 2008.

The meet referee reserves the right to make any adjustments to the provisions of the meet Announcement deemed necessary to ensure the fair and efficient running of the meet, with Prior approval from Program Operations.

**SCRATCH
PROCEDURE:**

Scratch sheets will be provided in the Coaches' Packets. These sheets **MUST** be returned 40 minutes before the session begins with the scratched swimmers names clearly identified.

WARM UPS:

Connecticut Swimming, Inc. warm-up guidelines will be observed. The Meet Director reserves the right to assign general warm-ups by team rather than by age or sex, if the size of the entry and considerations to safety so require. Details and lane assignments will be made available with the Coaches' Packets.

DIRECTIONS:

FROM 91 NORTH:

To exit 10 (Rt.40 ext). Follow to end heading North, take a right onto Rt. 10. Follow Rt. 10 into Cheshire. Pool is on the right across from the High School.

FROM 91 SOUTH:

To 691 West. Take exit 3 off 691, Cheshire. At light at the end of ramp, go left, heading south on Rt. 10. Follow Rt. 10 south through Cheshire. Pool is on the left across from the High School.

FROM 84 WEST:

To 691 East, take the Cheshire exit. Take a right at the end of the ramp onto Rt. 10 South through Cheshire. Pool is on the left across from the High School.

FROM 84 EAST:

To exit 26 (rt. 70). Follow Rt. 70 into Cheshire. At Rt. 10 intersection, take a right, heading South on Rt. 10 through Cheshire. Pool is on the left across from the High School.
