Beecher Road, Woodbridge, CT
- Facility:** Beecher Pool is a 6-lane by 25 yard facility. Automatic timing will be used (buttons). Starting blocks are at the deep end of the pool. *Seating for spectators is extremely limited.* Handicap/Elderly accessibility to pool deck, locker rooms and spectator area is accessible through main hallway ramp. Ample parking.

- Eligibility:** Swimmers must be 2008 USA Swimming registered members. All coaches must present a valid USA Swimming Coach Card to the Meet Director prior to commencement of any sanctioned swim meet and must have this card with them while on deck. .
- Entry Fee:** 11/12 Events - \$4.00 400 IM and 500 Free - \$5.00

- Entry Deadline:** **Friday, January 4, 2008.** CT Teams submitting entries on or before Wednesday, January 2 will be awarded acceptance priority over out of state entries. Entries will be accepted based on date/time of entries received until the meet is full. All teams are encouraged to send entries by e-mail, using Hy-Tek or LSA software. If using e-mail, please attach a hard copy, which will be

considered the official entry in the event of discrepancies. Please mail payment by Friday, January 4.

- Entries:** Session will be limited to 3.5 hours. Entries will be accepted in the order they are received until the meet is full. All entries are to be submitted using SCY times. The use of NTs is discouraged. Age of swimmer is determined as of January 13, 2008. Teams will be notified of any changes affecting their swimmers as soon as possible, after the final entry deadline. Meet Management reserves the right to limit heats, adjust warm-up and/or start times or make other changes to ensure a quality meet. All changes are subject to approval by CSI Program Operations. Connecticut Swimming guidelines will be observed at all sessions.
- Seeding:** Fastest to slowest, mixed (female and male combined).

Directions: Take the Merritt Parkway to Exit 59. At end of Exit ramp take left. Go under parkway to fourth traffic light – Lucy Street (Cleaners on left). Take left. Go to traffic light (People’s Bank in front of you) take a right. Go to second traffic light. Take left on to Route 114. Take second left on to Beecher Road. (If you go past the firehouse, you’ve gone too far). Go through four-way stop and Beecher Road School is on your right. Take left fork in driveway to go to the South School Entrance.

From Hartford: Take the Merritt Parkway to Exit 59. (Right after the tunnel). At the end of ramp take left and go to second traffic light – Lucy Street (Cleaners on left) and take left. Follow above directions.
