**MEET EMERGENCY NUMBER:** 203-848-0307

**MEET CLASSIFICATION:** This meet is open to all USA Swimming athletes and clubs.

**MEET FORMAT:** Timed finals, fastest to slowest, mixed, seeded by time only.

**SCRATCH PROCEDURE:** Scratches are due 20 minutes prior to the start of the meet.

**FACILITY:** Beecher Pool is a 6 lane, 25 yard facility. Semi-Automatic timing will be used, buttons, no pads. Seating is ample for a 1650 Freestyle only meet.

**DISABLED ACCESS:** From parking to rest rooms to seating, the pool is 100% accessible.

**COURSE:** SCY

**EVENTS:** see attached list.

**SESSION TIMES:** 7:30 Warm-up, 8:30 Start.

**WARM-UPS:** CT Swimming Warm-up Procedures will be in effect.

**ELIGIBILITY:** All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. 10/unders are not eligible for this meet. Any swimmer who is entered and is unregistered, will be scratched from the meet until registration is completed. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and have this card with them while on the deck.

**ADAPTED SWIMMING:** Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter the meet. If modifications to USA

Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability prior to competition.

**EVENT INFORMATION:** Athletes will be seeded by times only, not gender.

**ENTRY LIMITATIONS:** Maximum of 2 events per athlete. 10/unders are not eligible for this meet.

**ENTRY TIMES:** Submit entry times in SCY. No times are discouraged.

**DEADLINES:** Entry deadline is Wednesday, November 4, 2009. Emailed entries are preferred. Email entries to Dave Reilly, [dmr123@sbcglobal.net](mailto:dmr123@sbcglobal.net). If you are mailing the entry, mail to Dave Reilly, 57 Union Street, Guilford, CT 06437. All entries must be typed or printed legibly, and must use full names and registration numbers from USA Swimming registration. Entries will be accepted in the order they are received.

**ELECTRONIC ENTRIES:** Electronic entries that are in CL2 or SD3/SDIF may be emailed as an attachment to the above email address. Please check that your team name, address and contact information is listed correctly in this file. Payment may be sent to Dave Reilly, 57 Union Street, Guilford, CT 06437, or may be made on deck, day of meet. All entries will be accepted in the order they are received.

**ENTRY FEES:** \$7.50 per event.

**PAYMENT INSTRUCTIONS:** Make checks payable to Woodbridge Aquatic Club.

**CUT PROTOCOL:** The meet must end no later than Noon. Once received entries fill the meet to the noon deadline, no other entries will be accepted.

**RESERVE THE RIGHT TO MAKE CHANGES:** The meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet, with prior approval from Program Operations. Clubs will be notified of cuts no later than Wednesday PM before the meet.

**SAFETY:**

1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes.
2. No shaving is permitted at the competition site.
3. No glass containers are permitted within the facility.
4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
5. No electronic devices with cameras are permitted in the locker rooms.

**RULES:** Current USA Swimming rules will govern all competition.

**TIME TRIALS:** Not available.

**TIMERS OR WORK ASSIGNMENTS:** Entrants are to supply their own timer and lap counter.

**DECK ASSESS:** Only athletes, coaches, officials and official meet staff actively participating in the meet are permitted on the pool deck.

**SCORING:** The meet will not be scored.

**AWARDS:** No

**CONCESSIONS:** Minimal

**HOSPITALITY FOR COACHES AND OFFICIALS:** Yes

**PARKING:** Ample parking is available. Be sure to go to Beecher South, not Beecher North.

**DIRECTIONS:** Wilbur Cross Parkway to exit 59, from either direction.

Left off the exit, then left on Lucy Street. At end of Lucy Street take right onto Rte 63 (Amity Road). Up the hill take a left onto Rte 114 (Center Road). From Center Road take second left – Beecher Road. On Beecher Road go straight, thru 4 way stop. School entrance is first right after the 4 way stop. Go to the parking lot on your left.
