Terms & Conditions

Payment Terms:

Payment for the rental period is due prior to delivery. Payment may be made by credit card only on CTSWIM.org.

Processing of the payment will be held until the conclusion of the meet. Delays in the return of the equipment by the Renting Club shall be fined at the "Additional Days" rate.

- Rental rates are subject to change at the discretion of the Connecticut Swimming, Inc. Board of Directors.
- Equipment rentals may be requested by completing the CSI Equipment Rental Request Form at least three (3) weeks prior to the dates of the desired rental. Please complete the on-line order form located at https://www.ctswim.org/CTNet/CFPaintForm.aspx?f=98.
- CSI does not deliver or pick-up equipment. The Renting Club is responsible for all transportation of equipment. Equipment may be picked up or dropped off at the CSI equipment storage facility located in Meriden, CT (or at an alternate location of mutual convenience) by appointment ONLY with the Equipment Manager or Program Operations Vice-Chair.

- Equipment is expected to be returned in the same condition as when it was picked up. All equipment should be returned thoroughly dry. All cables and buttons should be neatly rolled up. Equipment returned wet or not properly rolled up will be assessed an additional \$100 cleaning charge which will be added to the rental charge.
- Risk of loss of or damage to the equipment or damage caused by the equipment is the responsibility of the Renting Club. If any equipment is returned damaged or equipment is missing, the Renting Club is responsible for the cost of repairs or, if necessary, replacement at current day replacement prices. A bill for damages or missing equipment will be rendered to the Renting Club.
- Renting Clubs with outstanding fines for late returns and/or damages will be considered clubs in poor-standing and the club's athletes will be unattached until the fine is paid. Fines may be appealed in writing within 30 days to the CSI Administrative Vice-Chair.
- CSI makes no warranty, express or implied, as to the condition or operation of the equipment, and does not guarantee flawless performance of the equipment. Renting Clubs are expected to be able to properly setup and takedown equipment including interfacing the rented equipment with club owned or other facility meet computers and printers. While equipment will be checked out for proper operation before a rental, it is strongly suggested that renting entities setup and checkout equipment operation the day before a meet starts. Renting Clubs shall immediately notify CSI of any defects or performance issues with the equipment. CSI does not provide any troubleshooting services to resolve equipment problems while it is out on a rental.
- CSI does not rent meet computers or printers. Renting Clubs are expected to use their own computers, stop watches and meet supplies for a meet.
- Equipment rentals may be denied to any club or organization that has outstanding and overdue financial obligations to CSI or has shown disregard for care of CSI equipment during prior rentals.
- CSI rents equipment as a service to CSI and non-CSI clubs and organizations. Rental rates are
 intended to recover a portion of the significant cost associated with offering a rental program. In
 addition to the cost of equipment, CSI must pay for storage, care and maintenance of the
 equipment, pay for insurance and administer the program.
