As a side note and to be perfectly clear, pools may open for LIFEGUARD TRAINING ONLY on June 10.

Additionally, I urge for the Head Coach and additional staff – coaches and facility employees to be on the call. The more that are educated and knowledgeable, the easier it will be for all when you begin practicing. This is aimed towards competitive swimming only and not swim lessons, diving, water polo or free swim.

<u>Pre-Registration</u> through CT Swimming's FAST system is required. Once registered, you will receive the ZOOM meeting information.
