## **OFFICER REPORTS**

SB1218- it is moving forward and would like to see a "yes" vote on this.

swimming. Want to bid back the open water championship in September. Henk has put USA Swimming pool cuts for open water championships online. Elections- in the process of ramping up and Dave Heller is in charge. A number of roles that are coming up and terming out.

**<u>Finance Vice-Chair</u>** – **James Doak-** going into our budget process. We are trying to do this on a zero basis.

Swimming a few events at regionals and at seniors. People have fewer bonus cuts this year. With declining registration this isn't great.

**Operational Risk Coordinator** – **Brandon Foster-** One incident this month. A swimmer bumped their head a couple of times into the wall doing backstroke. Need to follow up with swimmer.

**<u>Registration/Membership Coordinator</u> – Kathleen/Davide Mendonca-** Some courses need to redo the links for registration.

Zone Team Coordinator –Seana Bedard- not present

Diversity, Equity & Inclusion – Dennis Flores- not present

**OLD BUSINESS**- Board composition- adjusting our board membership. We had a 3 week period to review it. Didn't receive a review or comment last month.
