• Swimposium update- USA Swimming call last week- talked about USA vs. AAU Swimming. The pros and cons of disability legislation that is being proposed in September to the HOD. DEI- talked about swimclusion, and pros and cons of bulk renewal vs. self- renewal. Renewals have to be done by 9/1. You are opted- out automatically unless you opt-in.

Can nominate two people to go to Mighty Mike workshop which is Nov. 3-5. Not a great weekend for CT- High School Championships and the banquet. If interested in going please tell Rick.

• **Open Water, Adaptive Coordinator positions update-** Some people are interested in Open Water position. Bill Strickland, Jen Lyman. No one is interested as of yet for the Adaptive Coordinator. Leap Update- Will be working on it. Has to be in by the end of the month.

• **CT Swim Day at Quassy-** It was a manageable group this year. 205 people signed up. Relatively small compared to last year. Check-in was OK and well run. 183 people showed up. Rough numbers show \$3259.

EZ Retreat- Held at Colby. Great opportunity, great experience. Five swimmers signed up and went. One backed out and got a refund. Hopefully next year more athletes will go. We can send up to 8 women and 8 men.

#### NEW BUSINESS

- **Banquet-** Getting started. We lost money last year. Will make some changes to get more in line with the budget numbers. Culken Jones will be the EM CEspeaker. Will post on banquet page. He is an outstanding speaker.
- FAST/SWIMS 3.0 Update- Issue with FAST with bonus events and late qualifiers. It wasn't showing up. Had to re-open the entries. SWIMS 3.0- bulk registrations- if team ops-in team is responsible for all registrations even if one swimmer it is called a bulk swimmer. If you have a transfer swimmer they have to fill out the transfer form first before doing the bulk registration.
- **CSI Financials-** June 30 financials we are in good shape. 130 K net profit for the year. Will go down with LC, Senior travel and zones. Age groups did well- we broke even. Senior champs were light. Surcharges around the budget. Registrations are similar to last years, maybe slightly lower than last year.
