- Criteria for CT Swimming Scholar Athlete
 - MOTION: To add a time standard to the qualifications for CT Swimming Scholar Athlete.
 - PASSED 6-0
- Number of CT Swimming sanctioned meets to qualify for championships
 - SHORT COURSE
 - MOTION: If a swimmer joins a CT USA Swimming team from a LSC outside of CT after January 1st through the CT Swimming Championship deadline, and have the qualifying times for a CT Championship meet (Regionals and/or Age Groups) and can prove they competed in one sanctioned meet from their prior LSC, the championship sanction meet qualification for SC may be waived. (Said swimmer must compete in a LC meet to be eligible for LC championships.)
 - PASSED 6-0
 - LONG COURSE
 - MOTION: Sanctioned meet qualifications for LC Championship meets: one CT sanctioned short course and a CT sanctioned championship meet from the SC season immediately preceding the LC season or one CT sanctioned meet in the current LC season.
 - PASSED 6-0
 - MOTION: If a swimmer joins a CT USA Swimming team from a LSC outside of CT after the second meet entry deadline for LC season through the CT Swimming Championship deadline, and have the qualifying times for a CT Championship meet (Regionals and/or Age Groups) and can prove they competed in one sanctioned meet from their prior LSC, the championship sanction meet qualification for LC may be waived.
