MEET CLASSIFICATION: This meet is open to all USA Swimming athletes and clubs.

MEET FORMAT: The meet will be swum as Timed-Finals.

SCRATCH PROCEDURES: Scratch sheets will be provided and must be submitted 20 minutes after the start of warm-ups.

FACILITY: The Ocean Beach Pool is an 8 -lane, 50-meter pool. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming; Water depth at start end is: 11 feet Water depth at turn end is: 4 feet. We will be using a Colorado timing system. Spectator seating will be outside of the pool area on the grass, please bring deck chairs.

DISABLED ACCESS: The facility is equipped with handicapped parking, handicapped entrances, locker rooms and spectator areas are accessible. Please contact the meet director if special arrangements are needed.

COURSE: LCM.

SESSION TIMES: One session 5:15pm warm-up, 6:15pm start

WARM-UPS: CT Swimming warm-up procedures will be in effect

ELIGIBILITY: All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete registration procedures. Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

ADAPTED SWIMMING: Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability prior to competition.

ENTRY LIMITATIONS: An athlete is allowed to enter a maximum of 4 events.

ENTRY TIMES: Submit entry times in: LCM.

DEADLINES: Entry deadline is June 18, 2011. Mail hardcopy and payment to the entry chairperson: Terri Mauthe, 21 Harvest Glen, East Lyme, CT, 06333. All entries must be typed or printed legibly, and must use full names and registration numbers from USA Swimming registration. Date of entries will be determined by the date that payment is received.

ELECTRONIC ENTRIES: Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair, (Terri Mauthe) at Terri.Mauthe@gmail.com. Please check that your team name, address, and contact information are listed correctly in this file. Payment for entries is due within 5 days of submission of electronic entry. Teams are not considered entered until payment in full is received.

ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION: Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

ENTRY FEES: Electronic entries: \$7.00 for each individual event. Manual entries: \$10.00 for each individual event. No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry.

PAYMENT INSTRUCTIONS: Please make checks payable to ELBOE and mail to: Terri Mauthe, 21 Harvest Glen, East Lyme, CT, 06333. Payment must be received by 06/23/2011.

CUT PROTOCOL for INVITATIONALS: Entries will be accepted on a first come first served basis until the meet is full. The session will be limited to 3.5 hours in length. Clubs will be notified of cuts no later than June 24, 2011.

RESERVE THE RIGHT TO MAKE CHANGES:

The meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet, with prior approval from Program Operations. Clubs will be notified of cuts no later than June 24, 2011.

RELAYS: No Relays are offered at this meet.

SAFETY:

1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
2. No shaving is permitted at the competition site.
3. No glass containers are permitted within the facility.
4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
5. No electronic devices with cameras are permitted in the locker rooms.

RULES: Current USA Swimming rules will govern all competition.

TIME TRIALS: No time trials will be offered at this meet.

TIMERS, OFFICIALS OR WORK ASSIGNMENTS: Work assignments will be based on team entries and all teams will be notified of work assignments via email the Thursday prior to the meet. Teams supplying names of volunteers willing to officiate will have their timing assignments adjusted. DECK ACCESS: Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

SCORING: The meet will not be scored.
