MEET CLASSIFICATION: This meet is open to all USA Swimming athletes and clubs.

MEET FORMAT: The meet will be swum as Timed-Final. The 400's will be run fast to slow and mixed by gender according to seed time.

SCRATCH PROCEDURES: Coaches will receive a scratch sheet for the session of the meet in their information packets listing all of their swimmers and events for the session. Coaches must indicate all scratches on these sheets and turn them in to the office within one half hour after the beginning of warm-up.

FACILITY: The Yale Practice Pool is a 5 lane, 50 meter pool. Manual timing will be utilized. Deck space and spectator seating is limited. The competition course has not been certified in accordance with 104.2.2C(4). Water depth at start end is: 14 feet. Water depth at turn end is: 4 feet.

DISABLED ACCESS: The Payne Whitney Gymnasium is handicapped accessible. Parking can be found near and around the gymnasium; handicapped parking can be found on Tower Parkway in front of the gym.

COURSE: Long Course Meters

EVENTS: See attached list.

SESSION TIMES: General Warm up for all senior sessions, no lane assignments, unless the meet is fully subscribed. In that event, OMNI will split the warm up into 2 groupings. 12/under warm up will be broken into two groupings with assigned lanes followed by a sprint/circle swim session.

WARM-UPS: CT Swimming Warm-Up Procedures will be in effect. Warm up and start times for all sessions are subject to change depending upon the size of the meet.

ELIGIBILITY: All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete [registration procedures](#). Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

ADAPTED SWIMMING: Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability prior to competition.

EVENT INFORMATION: Deck entries will not be accepted.

ENTRY LIMITATIONS: Swimmers may compete in 3 events for the meet. Depending upon the size of the meet the 400 IM may be limited to 4 heats of women and 4 heats of men – 8 heats total. Swimmers who are “cut” from the event will have the opportunity to choose another event.

ENTRY TIMES: Submit entry times in: Long Course Meters. If there are no official times for an athlete, please submit estimated times. No Times “NT” will not be accepted.

DEADLINES: Entry deadline is May 9, 2011. Mail hardcopy and payment to: Tim Wise, 85 Merriman Road, Wethersfield, CT 06109. All entries must be typed or printed legibly, and must use full names and registration numbers from USA Swimming registration. No hard copy necessary unless using snail mail only. Entries will be accepted on a first come – first serve basis, determined by the date the check is received.

ELECTRONIC ENTRIES: Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at tim.wise@yale.edu. Please check that your team name, address, and contact information are listed correctly in this file.

ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION: Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

ENTRY FEES: Electronic entries: \$4.50 for individual events. Manual entries: \$10.00 per event. No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry.

PAYMENT INSTRUCTIONS: Please make checks payable to OMNI and mail to: Tim Wise, 85 Merriman Road, Wethersfield, CT 16109. Payment must be received by May 12, 2011. Payment is not optional.

CUT PROTOCOL: If a session is over subscribed the 7/under swimmers will be cut. Depending upon the size of the meet the 400 IM may be limited to 4 heats of women and 4 heats of men – 8 heats total. Swimmers who are “cut” from the event will have the opportunity to choose another event. If the time line estimate still exceeds four hours teams will be cut based on the date of receipt of their entry, determined by the date the check is received. Clubs will be notified no later than the Tuesday before the meet.

RESERVE THE RIGHT TO MAKE CHANGES: The meet referee reserves the right to make any adjustments to the meet announcement deemed necessary to ensure the fair and efficient running of the meet, with prior approval from Program Operations. Clubs will be notified of cuts no later than Tuesday before meet.

SAFETY:

1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
2. No shaving is permitted at the competition site.
3. No glass containers are permitted within the facility.
4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
5. No electronic devices with cameras are permitted in the locker rooms.

RULES: Current USA Swimming rules will govern all competition.

TIME TRIALS: Time trials will be offered at the discretion of the meet referee if time allows. Time trials are \$10.00 for individual events. Time trial events count toward the total number of event limitations per session.

TIMERS, OFFICIALS OR WORK ASSIGNMENTS: Teams will be required to supply timers in proportion to the size of their entry. Please note that timers are required for the duration of the session. Competent officials interested in working at the meet can contact the meet director at tim.wise@yale.edu. Officials who volunteer before May 10th will receive credit towards their team work assignment.

DECK ACCESS: Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

SCORING: The meet will not be scored.

AWARDS: Awards will not be given.

CONCESSIONS: Will be offered – Metro Swim Shop will also be here.

HOSPITALITY FOR COACHES AND OFFICIALS: yes
