MEET CLASSIFICATION: This meet is open to USA Swimming member athletes and clubs.

MEET FORMAT: The meet will be swum as timed finals.

SCRATCH PROCEDURES: Scratches will be due no later than 30 minutes prior to the start of the session.

FACILITY: The University of Connecticut, Wolff-Zackin Natatorium, Storrs, CT. is a six lane 50 meter facility with non-turbulent lane lines. The pool is equipped with a Colorado Timing System, touch pads and an electronic scoreboard. There is spectator seating for 800, including wheelchair accessible spectator area and entrance. The pool is located on the University of Connecticut Storrs campus, at the intersection of Hillside Road and Stadium Road.

DISABLED ACCESS: Handicapped parking is located immediately outside the main entrance to the pool. Handicap access to the locker room facilities is on deck level. Locker rooms and spectator areas are handicap accessible.

COURSE: LCM.

SESSION TIMES: 12:15pm Warm-Up; 1:00pm Start

WARM-UPS: CT Swimming Warm-Up Procedures will be in effect.

ELIGIBILITY: All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Age on the first day of the meet

shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete <u>registration procedures</u>. Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

ADAPTED SWIMMING: Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability <u>prior</u> to competition.

EVENT INFORMATION: Deck Entries will not be accepted.

ENTRY LIMITATIONS: Swimmers may enter up to 4 events per day.

ENTRY TIMES: Submit entry times in LCM. No Times are discouraged.

DEADLINES: Entry deadline is Monday June 13, 2011. Mail hardcopy and payment to the entry chairperson: Bill Ball at 309 Village Hill Road Willington, CT 06279. All entries must be typed or printed legibly, and must use full names and registration numbers from USA Swimming registration. Date of entries will be determined by the date payment is received.

ELECTRONIC ENTRIES: Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at ballb@ccsu.edu. Please check that your team name, address, and contact information are listed correctly in this file. Payment for entries is due by the entry deadline; teams are not considered entered until payment is received.

ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION: Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

ENTRY FEES: Electronic entries: \$8.00 for individual events. Manual entries: \$10.00 for individual events. No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry.

PAYMENT INSTRUCTIONS: Please make checks payable to SoNoCo Swim Club and mail to: Bill Ball 309 Village Hill Road Willington, CT 06279. Payment must be received by June 13, 2011.

CUT PROTOCOL: Entries will be accepted on a first come first served basis until the meet is full. Clubs entering the Connecticut Senior Invite will be given entry priority. Sessions will be limited to 3.5 hours in length. Clubs will be notified of cuts no later than Monday before the meet.

RESERVE THE RIGHT TO MAKE CHANGES: The meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet, with prior approval from Program Operations. Clubs will be notified of cuts no later than Monday before the meet.

RELAYS: No relays will be offered at this meet.

SAFETY:

- 1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
- 2. No shaving is permitted at the competition site.
- 3. No glass containers are permitted within the facility.
- 4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
- 5. No electronic devices with cameras are permitted in the locker rooms.

RULES: Current USA Swimming rules will govern all competition.

TIME TRIALS: No Time Trials will be offered.

TIMERS, OFFICIALS OR WORK ASSIGNMENTS: Work assignments will be based on team entries and all teams will be notified of work assignments via email on the Wednesday prior to the meet.

DECK ACCESS: Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

SCORING: The meet will not be scored.

AWARDS: No awards will be given at this meet.

HOSPITALITY FOR COACHES AND OFFICIALS: Yes

DIRECTIONS: Take I-84 to Route 195, exit 68. Follow Route 195 for 7 miles to the middle of the campus. When the lake is on your right, take the next right. Follow your way through the campus towards the silver dome. This is the field house; the pool is in the adjacent brick building.
