MEET CLASSIFICATION: This meet is open to all USA Swimming athletes and clubs.

MEET FORMAT: The meet will be swum as timed-final. Friday evening's events will be seeded fastest to slowest, alternating heats of girls and boys. At the conclusion of Saturday's 13/Over session, a short 40 minute session of 13/Over 50 meter events will be offered. There will be no break between these two sessions.

SCRATCH PROCEDURES: Scratches will be due 45 minutes prior to the start of each session. After that time, any unsubmitted scratches will remain as entries for that session.

FACILITY: Wesleyan University's Freeman Athletic Center Pool is 8 lanes, 50 meters. Colorado timing will be used. Spectator seating is limited; spectators are asked not to sit in the stairways in the spectator section. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. Colorado electronic timing system. Water depth at start end is 14 ft. and turn end is 4 ft.

DISABLED ACCESS: The Aquatic Center is handicapped accessible, with handicapped viewing area available. Contact the meet director for additional information and/or if special arrangements are required.

WARM-UPS: CT Swimming Warm-Up Procedures will be in effect.

ELIGIBILITY: All athletes must be current athlete members of USA Swimming. Age on the first day of the

meet shall determine the swimmer's age and age group for the meet. Any swimmer who is entered and is unregistered will be scratched from the meet until registration is completed. See [CT Swimming athlete registration procedures](#). Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

ADAPTED SWIMMING: Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability prior to competition. ENTRY LIMITATIONS:

Session I and Session IV: 2 individual events per athlete. No time trials.
Sessions II, III, V, VI: 4 individual events per session, including time trials.

ENTRY TIMES: Submit entry times in LCM. Please do not use NT as an entry time, instead please use an estimated time.

DEADLINES: Entry deadline is June 8, 2012. Email entries are the preferred method of submitting an entry for this meet. Entries will be accepted in the order they are received. Mail payment (and entry if using snail mail) to the entry chair: Dave Reilly, 57 Union Street, Guilford, CT, 06437. All entries must be typed or printed legibly, and must use full names and registration numbers from USA Swimming registration. Payment must be received within 10 days of the accepted entry or the entry will be rejected. The entry chair will acknowledge receipt of entry via email, within 24 hours after receipt of entry. *After payment only*, entries may be updated until Tuesday July 3. After July 3 no changes to the entry will be accepted.

CONNECTICUT-ONLY DEADLINE: The CT deadline is June 7, 2012. CT clubs meeting this deadline will be entered before out of state clubs. Out of state entries will be accepted only if room exists on June 8 for acceptance of additional entries. Out of state entries will then be entered based on the order they were received.

ELECTRONIC ENTRIES: Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at dmr123@sbcglobal.net. Please check that your team name, address, and contact information are listed correctly in this file. Please see the above Deadline and Connecticut-Only Deadline for entry deadlines and payment deadlines.

ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION: Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) Be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

ENTRY FEES: Electronic entries: \$6.00 for individual events. Manual entries: \$10.00 for individual events. No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry.

PAYMENT INSTRUCTIONS: Please make checks payable to Woodbridge Aquatic Club and mail to: Dave Reilly, 57 Union Street, Guilford, CT, 06437. Payment must be received no later than 10 days after the receipt of the entry or the entry will be rejected.

CUT PROTOCOL for INVITATIONALS: Friday PM session will be limited to 3.5 hours of competition. All 13/Over sessions will be limited to 4.5 hours of competition. All 12/Under sessions will be limited to 4 hours of competition. Entries for each session will be accepted until the timeline for that session fills.

RESERVE THE RIGHT TO MAKE CHANGES: The meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet, with prior approval from Program Operations. Clubs will be notified of these adjustments no later than Monday before the meet.

RELAYS: None

SAFETY:

1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
2. No shaving is permitted at the competition site.
3. No glass containers are permitted within the facility.
4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
5. Electronic audio or visual recording devices, including cell phones, are not permitted in changing areas, rest rooms, or locker rooms.

RULES: Current USA Swimming rules will govern all competition.

TIME TRIALS: Yes. Time trials will be offered at the discretion of the meet referee if time allows except on Friday and Saturday evening. Time trials are \$10.00 for individual events. Time trial events count toward the total number of event limitations per session. Time Trial events are limited to those events published in this meet announcement.

TIMERS, OFFICIALS OR WORK ASSIGNMENTS: Friday evening session requires that all swimmers provide their own timer. Timing assignments will be published no later than Tuesday before the meet.

DECK ACCESS: Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

SCORING: The meet will not be scored.
