**MEET CLASSIFICATION:** This meet is open to all USA Swimming athletes and clubs.

**MEET FORMAT:** The meet will be swum as timed-finals.

**SCRATCH PROCEDURES:** Scratches are due 30 minutes before the start of the session.

**FACILITY:** The Norwalk High School Pool is a 6-lane, 25-yard pool. Colorado Timing System, touch pads and six-lane score board assure a quality timing system display of events. The competition course has not been certified in accordance with 104.2.2C (4). Water depth at start end is: 12 feet. Water depth at turn end is: 4.5 feet.

**DISABLED ACCESS:** Handicap accessibility throughout the facility.

**COURSE:** SCY.

**EVENTS:** See attached list.

**SESSION TIMES:** Session 1: 5:15 P.M. Warm-up, 6:00 P.M. Start

**WARM-UPS:** CT Swimming Warm-Up Procedures will be in effect.

**ELIGIBILITY:** All athletes must be current athlete members of USA Swimming and no older than nine years of age. Age on the first day of the meet shall determine the swimmer's age and

age group for the meet. Any swimmer who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete [registration procedures](#). Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

**ADAPTED SWIMMING:** Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability prior to competition. Adapted athletes may direct questions to [Mark Kinne](#), Adapted Athlete Committee Chair.

**ENTRY LIMITATIONS:** Maximum of 5 events per day plus relays.

**ENTRY TIMES:** Submit entry times in SCY. No Times are discouraged.

**DEADLINES:** Entry deadline is Friday May 19, 2012.

All entries must be typed or printed legibly, and must use full names and registration numbers from USA Swimming registration. Entries are official upon receipt of the check.

**CONNECTICUT-ONLY DEADLINE:** May 18, 2012. Entries will be considered received when the entry file is received (email or mail). CT clubs meeting this deadline will be entered before out of state clubs.

**OUT OF STATE DEADLINE:** May 19, 2012. Out of state teams sending entries will be based on the subscription of CT teams and taken in order of a received email entry.

**ELECTRONIC ENTRIES:** Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at [byte1inc@optonline.net](mailto:byte1inc@optonline.net). Please check that your team name, address, and contact information are listed correctly in this file. When payment is received the entry is considered officially in the meet.

**ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION:** Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the

swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

**ENTRY FEES:** Electronic entries: \$5.00 for individual events and \$10.00 for relays. No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry

**CUT PROTOCOL for INVITATIONALS:** Should the meet be oversubscribed the cut protocol is as follows:

- Events will be cut from 5 to 4 events
- Events will be cut from 4 to 3 events
- Relays will be eliminated
- Club entries will be cut in reverse order of their receipt

**RESERVE THE RIGHT TO MAKE CHANGES:** The meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet, with prior approval from Program Operations. Clubs will be notified of cuts no later than Monday before the meet.

**RELAYS:** Yes; all relay swimmers must be officially entered in the meet.

**SAFETY:**

1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
2. No shaving is permitted at the competition site.
3. No glass containers are permitted within the facility.
4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
5. Electronic audio or visual recording devices, including cell phones, are not permitted in changing areas, rest rooms, or locker rooms.

**RULES:** Current USA Swimming rules will govern all competition.

**TIME TRIALS:** Time trials will be offered at the discretion of the meet referee if time allows. Time trials are \$7.00 for individual events and \$12.00 for relays. Time trial events count toward

the total number of events per session. Will be held if time allows or at the discretion of the meet referee. Time Trial events are limited to those events published in this meet announcement.

**TIMERS, OFFICIALS OR WORK ASSIGNMENTS:** Volunteers will be based on the number of swimmers in the meet.

**DECK ACCESS:** Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

**SCORING:** The meet will be scored. Scoring will be the standard First through sixteenth place.

**AWARDS:** Ribbons will be awarded to the top 6 finishers in all individual events, and top 3 finishers in each relay event. Teams are responsible for picking up their own awards.
