MEET CLASSIFICATION: This meet is closed and is by invitation only. Invited clubs are: FVYM, GLAS, and CAC.

MEET FORMAT: The meet will be swum as Timed-Finals. Events will be Senior.

SCRATCH PROCEDURES: Coaches will receive scratch sheets at the beginning of the session. Scratch sheets must be returned within 20 minutes after the start of warm-ups. If a scratch sheet is not received by that deadline all swimmers will be considered NOT to be scratched and will be seeded in their entered events, except that any over-entered swimmers will be scratched from their last event(s) until they are in compliance with entry rules

FACILITY: The Main Street Competition Pool is an 6-lane, 50-meter pool. Water depth at start end is: 12 feet. Water depth at turn end is: 3 ½ Feet. The competition course has not been certified in accordance with 104.2.2C(4). Manual Timing. Bringing your own chair is recommended for spectators.

Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

DISABLED ACCESS: Handicapped parking is available in front of Canton Mills Pond. The practice pool deck and spectator area are handicapped friendly. Contact the meet director for more information.

WARM-UPS: CT Swimming Warm-Up Procedures will be in effect.

ELIGIBILITY: FVYM, GLAS, OAK, and CAC. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete registration procedures. Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

ADAPTED SWIMMING: Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability prior to competition. Adapted athletes may direct questions to Mark Kinne, Adapted Athlete Committee Chair.

EVENT INFORMATION: No deck entries.

ENTRY LIMITATIONS: Swimmers may compete in 4 events. In the event of oversubscription, the host reserves the right to limit swimmers to 3 events. *

CSI "APPROVED MEET" LIMITATIONS WITH REGARD TO CSI COMPETITION AND PROGRAMS: This off-calendar approved meet will not count toward the regularly scheduled sanctioned meet eligibility requirement for CSI championships (Regional Championships and Age Group Championship). This meet will not count toward the eligibility requirement of Connecticut Swimming Scholar Athlete, Athlete Travel Assistance, or other CSI recognition programs with meet eligibility requirements. This meet will not count toward the regularly scheduled sanctioned meet eligibility requirement for CT Zone Team selection.

ENTRY TIMES: Submit entry times in: SCY or LCM.

CONNECTICUT-ONLY DEADLINE: CT deadline is July 4th, 2013.

ELECTRONIC ENTRIES: Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at spencer.hartmann@ctoak.org. Please check that your team name, address, and contact information are listed correctly in this file

ENTRY FEES: Electronic entries: \$7.00 for individual events. Manual entries: \$8.00 for individual events, No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry

SAFETY:

1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
2. No shaving is permitted at the competition site.
3. No glass containers are permitted within the facility.
4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
5. No electronic audio or visual recording devices, including cell phones, are permitted in changing areas, rest rooms, or locker rooms.

RULES: Current USA Swimming rules will govern all competition.

TIME TRIALS: No

TIMERS, OFFICIALS OR WORK ASSIGNMENTS: Participating clubs will be notified of work assignments by the Monday before the meet.

DECK ACCESS: Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.
