**MEET TYPE:** Sanctioned

**MEET CLASSIFICATION:** This meet is open to all USA Swimming athletes and clubs.

**MEET FORMAT:** The meet will be swum as a Timed-Final, fastest to slowest alternating Girls and Boys.

**SCRATCH PROCEDURES:** Coaches will receive a scratch sheet for the session of the meet in their information packets listing all of their swimmers and events for that session. Coaches must indicate all scratches on these sheets and turn them in to the office within one half hour after the beginning of warm-up. Swimmers that are not scratched will be left in the meet.

**FACILITY:** Zeigler Pool at the Darien YMCA is a 6 lane 25 yard pool. Water depth at start end is: 10 feet. Water depth at turn end is: 4 ½ feet. The competition course has not been certified in accordance with 104.2.2C(4). Colorado timing will be used. Spectator seating of 150.

Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

**SESSION TIMES:** General Warm-up 4:15p Meet Start 5:30p

**WARM-UPS:** CT Swimming Warm-Up Procedures will be in effect. There will be one general warm-up session using all 6 lanes.

**ELIGIBILITY:** All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete <u>registration</u> <u>procedures</u>. Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

**ADAPTED SWIMMING:** Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability <u>prior</u> to competition. Adapted athletes may direct questions to <u>Mark Kinne</u>, Adapted Athlete Committee Chair.

**ENTRY LIMITATIONS:** A swimmer may swim one individual event.

**ENTRY TIMES:** Submit entry times in SCY.

**DEADLINES: Final entry deadline June 5<sup>th</sup>.** Please send entry via email. No hardcopy necessary unless using 'snail' mail only. If hand writing, all entries must be typed or printed legibly, and must use full names and registration numbers from USA Swimming registration Mail hardcopy, if necessary, and payment to the entry chairperson:

CT ENTRY DEADLINE: May 21st. Any CT clubs meeting this deadline will be entered before out of state clubs. Receipt of email entry will determine date of entry.

**ELECTRONIC ENTRIES:** Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at <a href="mailto:piranha@darien-ymca.org">piranha@darien-ymca.org</a>. Please check that your team name, address, and contact information are listed correctly in this file. ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION: Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

**ENTRY FEES:** Electronic entries: \$10 for individual events. Manual entries: \$15.00 for individual events. No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry.

**PAYMENT INSTRUCTIONS**: Checks payable to **Darien YMCA**, **Piranha Swim Club** and mail to the entry chair at the address listed above. Payment must be received by 6/11/14.

**CUT PROTOCOL:** In case of oversubscription, out-of-state teams will be cut first then CT teams based on entry date. Clubs will be notified of cuts no later than Monday before the meet.

**RESERVE THE RIGHT TO MAKE CHANGES:** The meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet, with prior approval from Program Operations. Clubs will be notified of changes no later than Monday before the meet.

#### **SAFETY:**

- 1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
- 2. No shaving is permitted at the competition site.
- 3. No glass containers are permitted within the facility.
- 4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
- 5. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

#### PHOTOGRAPHY AND VIDEO RECORDING:

Meet Management has the full authority to restrict any and all photography and visual recording at the meet. Photography or video recording (using cameras, video cameras, iPads, cell phones, etc) from the deck is prohibited by all individuals other than participating Coach and Athlete Members unless prior authorization from the Meet Referee or his/her designee has been granted. Flash photography is prohibited during the start of any heat, including whenever any swimmer is stepping up or standing on a block for the purpose of the start of a heat.

Additionally, the following "Non-Camera Zones" shall be enforced:

- Photography or video recording and the use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.
- Photography or video recording (using cameras, video cameras, iPads, cell phones, etc) is not permitted in the area immediately behind the starting blocks at either end of the racing course(s) while they are in use for "race starting purposes" during competition and warm-ups.
- Additional "Non-Camera Zones" may be designated by Meet Management.

Any individual failing to abide by these rules may be ejected from the facility and be subject to a Code of Conduct violation at the discretion of Meet Management.

**RULES:** Current USA Swimming rules will govern all competition.

**TIME TRIALS:** Time trials will be offered at the discretion of the meet referee if time allows. Time trials are \$16.00 for individual events. Time trial events count toward the total number of event limitations per session. Time Trial events are limited to those events published in this meet announcement.

**TIMERS, OFFICIALS OR WORK ASSIGNMENTS:** Each swimmer must provide their own timer and counter for this meet. Please contact Gigi Kearney, <a href="mailto:chiquitapt@optonline.net">chiquitapt@optonline.net</a>.

**DECK ACCESS:** Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

**SCORING:** The meet will not be scored.

**AWARDS:** Ribbons for individual places 1-3.

**CONCESSIONS:** No, but the Y has vending machines and an Embody Café in the lobby of the building.

**HOSPITALITY FOR COACHES AND OFFICIALS:** A small coaches' and official's hospitality will be located on deck near the computer stand

**PARKING:** Parking can be done at the YMCA. Overflow parking is on Saltbox Lane (the side street next to the church across the street from the Y). NO PARKING AT THE CHURCH OR ON SEAVIEW AVE OR LIGHTHOUSE ROAD.

#### **DIRECTIONS:**

<u>I-95 Southbound:</u> Exit 11, US 1 (Post Rd.) Darien. Take left at bottom of ramp onto US 1 South (West). Go through 5 stop lights. The YMCA will be on your left (small sign). If you enter Stamford, you've traveled too far.

<u>I-95 Northbound</u>: Exit 9. Take left at end of ramp. Take right at light onto US 1 North (East). Follow US 1 into Darien. YMCA will be on your right (small sign). If you hit a stop light, in Darien, you've traveled too far.

**Merritt Parkway (Route 15):** Exit 37, New Canaan & Darien. At the end of ramp, take a right onto CT 124. Follow CT 124 into Darien to intersection with US 1 (Post Rd.). Turn right onto US 1. Go through downtown Darien under RR truss and I-95 overpass. Go through 5 stop lights. The YMCA will be on your left (small sign). If you end up in Stamford, you've traveled too far.
