MEET TYPE: Sanctioned.

MEET CLASSIFICATION: This meet is open to all USA Swimming athletes and clubs.

MEET FORMAT: The meet will be swum as Timed-Final. Friday's events will be swim fastest to slowest, alternating girls and boys. Swimmers must provide their own timer. The estimated allotted time for Saturday and Sunday sessions will be the following: 10/Under sessions – 2:15. 11/12 sessions – 2:45. 13/Over sessions – 3:50. While these times may be adjusted dependent upon entry pressures, Saturday and Sunday competitions should end no later than 6:00 P.M.

SCRATCH PROCEDURES: Scratch sheets are due at the computer table no later than 30 minutes before the start of the meet. Scratch sheets not submitted by this deadline will be considered as having no scratches.

FACILITY: Wesleyan University's Freeman Athletic Center Pool is 8 lanes, 50 meters. Water depth at the start end is 14 ft. Water depth at the turn end is 5 ft. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. Colorado timing will be used.

SPECTATOR SEATING: Limited to a maximum of 289 spectators. Sitting or blocking the aisles is prohibited. Chairs, or like furniture, are prohibited. No chairs are allowed in front of the lobby's glass viewing area. With the exception of handicapped seating, this area is standing room only.

DISABLED ACCESS: The aquatic center is handicapped accessible, with a handicapped viewing area available. Contact the meet director for additional information and/or if special arrangements are required.

WARM-UPS: CT Swimming Warm-Up Procedures will be in effect. Friday's session will be an open warm-up with designated lanes for 12/Under and 13/Over. Saturday and Sunday 12/Under sessions will have 1-20 minute team assigned general warm-up and Saturday and Sunday 13/Over sessions will have 1-25 minute team assigned general warm-up. All general warm-ups of all sessions will conclude with a 10 minute open warm-up using dedicated lanes for 1-way sprints, pace, and circle swimming.

ELIGIBILITY: All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete <u>registration</u> <u>procedures</u>. Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

ADAPTED SWIMMING: Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability <u>prior</u> to competition. Adapted athletes may direct questions to <u>Mark Kinne</u>, Adapted Athlete Committee Chair.

EVENT INFORMATION: Friday events will be swim fastest to slowest, alternating girls and boys. Swimmers must provide their own timer.

SESSION LIMITATIONS, MAXIMUM POOL DECK OCCUPANCY: No session shall exceed a 256 person maximum on-deck occupancy. This figure includes all swimmers, coaches, meet officials and meet volunteers.

SESSION LIMITATIONS, SWIMMERS: When factoring in meet officials, volunteers, and coaches with respect to the maximum on-deck occupancy, the number of swimmers accepted each session will be limited to 210, before scratches. Depending on the number of swimmers in any given session, some teams may be asked to situate themselves in an area of the facility other than the pool deck.

SESSION LIMITATIONS, COACHES: Teams with 12 or fewer swimmers entered each session are allowed 1 coaching pass for that session. Teams with 13 – 36 swimmers entered each session are allowed 2 coaching passes for that session. Teams larger than 36 swimmers in a session are allowed 3 coaching passes for that session.

SESSION LIMITATIONS, OFFICIALS: Officials interested in working this meet are to contact the Meet Referee, Julia Shi, at <u>julia.shi@yale.edu</u> prior to June 6. Walk-on officials will be invited to work the meet only if needed.

ENTRY LIMITATIONS, SWIMMERS: Swimmers are limited to entering and swimming in a maximum of 2 events on Friday, and 4 events each on Saturday and Sunday.

SPECIAL INSTRUCTIONS FOR SWIMMERS AND COACHES: Personal chairs are not allowed on the Wesleyan pool deck during the conduct of this meet. Chairs and bleachers will be provided; all chairs must be situated against the walls of the facility, not obstructing on deck pathways.

Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

ENTRY TIMES: Submit entry times in LCM. Please do not use NT as an entry time. In consideration of fair seeding, please provide a responsible estimate.

DEADLINES: Friday, May 23, 2014. Email entry files to Dave Reilly, dmr123@sbcglobal.net. Payment is due 5 business days after receipt of entry has been confirmed. Mail payment to Dave Reilly, 57 Union Street, Guilford, CT 06437. Teams will receive confirmation of receipt of entry, via email, within 24 hours of receiving that entry. This confirmation will include notice of acceptance or rejection of the entry. Entries will be accepted in the order they are received. In the event you are not emailed confirmation of receiving the entry within 24 hours after sending it, please email the meet director immediately. If you have not received a confirmation, you need to assume the entry was not delivered.

CONNECTICUT-ONLY DEADLINE: Friday, May 2, 2014. CT clubs meeting this deadline will be entered before out-of-state clubs. After this deadline, entries from in-state and out-of-state will be considered equally, in the order they have been received.

ELECTRONIC ENTRIES: Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format must be emailed as an attachment to the entry chair at dmr123@sbcglobal.net. Please check that your team name, address, and contact information are listed correctly in this file. Remember, payment is due 5 business days after confirmation of receipt of the entry.

ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION: Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) Be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

ENTRY FEES, FRIDAY: \$7.00 per event.

ENTRY FEES, SATURDAY: \$25.00 per swimmer per session. **ENTRY FEES, SUNDAY**: \$25.00 per swimmer per session.

PAYMENT INSTRUCTIONS: Please make checks payable to Woodbridge Aquatic Club and mail to Dave Reilly, 57 Union Street, Guilford, CT 06437.

CUT PROTOCOL: Due to Wesleyan's 256 maximum deck occupancy policy, Woodbridge Aquatic Club will limit the number of swimmers entered in each session to a maximum of 210 before scratches.

RESERVE THE RIGHT TO MAKE CHANGES: The meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet, with prior approval from Program Operations. Clubs will be notified of changes no later than Monday before the meet.

RELAYS: No.

SAFETY:

- 1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
- 2. No shaving is permitted at the competition site.
- 3. No glass containers are permitted within the facility.
- 4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
- 5. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms

PHOTOGRAPHY AND VIDEO RECORDING:

Meet Management has the full authority to restrict any and all photography and visual recording at the meet. Photography or video recording (using cameras, video cameras, iPads, cell phones, etc.) from the deck is prohibited by all individuals other than participating Coach and Athlete Members unless prior authorization from the Meet Referee or his/her designee has been granted. Flash photography is prohibited during the start of any heat, including whenever any swimmer is stepping up or standing on a block for the purpose of the start of a heat.

Additionally, the following "Non-Camera Zones" shall be enforced:

- Photography or video recording and the use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.
- Photography or video recording (using cameras, video cameras, iPads, cell phones, etc.) is not permitted in the area immediately behind the starting blocks at either end of the racing course(s) while they are in use for "race starting purposes" during competition and warm-ups.
- Additional "Non-Camera Zones" may be designated by Meet Management.

Any individual failing to abide by these rules may be ejected from the facility and be subject to a Code of Conduct violation at the discretion of Meet Management.

RULES: Current USA Swimming rules will govern all competition.

TIME TRIALS: Time trials will be offered at the discretion of the meet referee if time allows. Time trials are \$10.00. Time trial events count toward the total number of event limitations per session. Time Trial events are limited to those events published in this meet announcement.

TIMERS, OFFICIALS OR WORK ASSIGNMENTS: Teams will be assigned work assignments based on the size of their entry. Swimmers must provide their own timer for any Friday event. Participating clubs will be notified of work assignments by the Monday before the meet.

DECK ACCESS: Only athletes, coaches, officials, and official meet staff (meet volunteers) actively participating in the meet are permitted on the pool deck.

SCORING: The meet will not be scored.

AWARDS: No.

CONCESSIONS: Hosted by Wesleyan University.

HOSPITALITY FOR COACHES AND OFFICIALS: Hosted by Woodbridge Aquatic Club.

PARKING: Ample parking is available in various lots on campus.
