**MEET TYPE:** Sanctioned

**MEET CLASSIFICATION:** This meet is open to all USA Swimming athletes and clubs.

**MEET FORMAT:** The meet will be swum as Timed-Finals. Friday night events will be swum fastest to slowest and alternating girls/boys. Swimmers will need their own timers. There will be a 10 minute break between the 400 IM and the 400 Freestyle events.

**SCRATCH PROCEDURES:** Scratch sheets are due to the computer desk no later than 15 minutes after the start of the session warm-up. If a scratch sheet is not turned in, it will be assumed that the team is not in attendance and the entire team will be scratched from that session.

**FACILITY:** Wesleyan University's Freeman Athletic Center Pool is 8 lanes, 50 meters. Water depth at start end is 14 ft. and turn end is 4 ft. Colorado electronic timing system will be utilized. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. No locks may be left on Wesleyan lockers. No shaving on premises is permitted.

Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

Wesleyan has strict policies regarding the use of the Freeman Athletic Center including limits on both deck and spectator area occupancy as well as limitations on the use and placement of chairs in the lobby. It is imperative that all individuals attending the meet be aware of and adhere to the rules and procedures outlined below.

**PLEASE READ THOROUGHLY AND CAREFULLY.**

**Spectator Seating and Waiting areas**

- Personal folding chairs are allowed ONLY in the lobby perimeter.
- No spectators or swimmers will be permitted to congregate in the center of the front lobby of the Athletic Center.

- No folding chairs are permitted in the pool area, hockey rink, or field house.

### **Spectator area (stands)**

- Seating in the spectator seats will be limited to 340.
- Only individuals with disabilities that cannot access to the stands will be permitted in the spectator viewing area (open space in front of the large window overlooking pool).

### **Pool and Pool Deck**

- Deck Occupancy is 350.
- Only swimmers and meet workers with proper credentials (administrative, coaches, officials, timers, and marshals) will be allowed on the pool deck.

**DISABLED ACCESS:** The Aquatic Center is handicapped accessible, with handicapped viewing area available. Contact the meet director for additional information and/or if special arrangements are required.

**WARM-UPS:** CT Swimming Warm-Up Procedures will be in effect. Friday's session will be an open warm-up with designated lanes for 12/Under and 13/Over. Saturday and Sunday all sessions will have 2 - 25 minute team assigned general warm-ups. All general warm-ups of all sessions will conclude with a 10 minute open warm-up using dedicated lanes for 1-way sprints, pace, and circle swimming.

**ELIGIBILITY:** All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete [registration procedures](#). Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

**ADAPTED SWIMMING:** Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability prior to competition. Adapted athletes may direct questions to [Mark Kinne](#), Adapted Athlete Committee Chair.

**ENTRY LIMITATIONS:** Swimmers may enter and compete in no more than 2 events on Friday; 5 events per day on Saturday/Sunday

**ENTRY TIMES:** Submit entry times in LCM. Please do not use NT as an entry time, instead please use an estimated time.

**DEADLINES:** Entry deadline is Tuesday, May 22, 2015. Mail hardcopy and payment to the entry chairperson: Lynne Benavides, 15 Frances Barber Dr. Hope Valley, RI 02832. All entries must be typed or printed legibly, and must use full names and registration numbers from USA Swimming registration. An entry will be officially considered in the meet when the entry has been received.

**CONNECTICUT-ONLY DEADLINE:** CT deadline is Wednesday, April 15, 2015 at 12pm. CT clubs meeting this deadline will be entered before out of state clubs. Should space still be available after April 15, out-of-state teams will be admitted based on when their entry is received.

**ELECTRONIC ENTRIES:** Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at [jackboss2000@gmail.com](mailto:jackboss2000@gmail.com). Please check that your team name, address, and contact information are listed correctly in this file. An entry is considered complete, and the team entered in the meet, when the entry is received. Payment is due prior to the start of the meet.

**ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION:** Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance; 2) be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

**ENTRY FEES:** Electronic entries: Individual events - \$8.00. No refunds will be given for entries once they are accepted.

**PAYMENT INSTRUCTIONS:** Please make checks payable to CAC and mail to: Lynne Benavides, 15 Frances Barber Dr. Hope Valley, RI 02832. Payment must be received by Friday, June 5, 2015.

**CUT PROTOCOL:** Each session will be considered full when it reaches time line restriction. Teams will be cut based on date of receipt of entry (with CT teams being protected if they are in by the CT only deadline). Entries for each session will be accepted until the maximum session time line for that session fills. Clubs will be notified of changes no later than Monday before the meet.

**RESERVE THE RIGHT TO MAKE CHANGES:** With prior approval from Program Operations and in accordance with CSI Policies, the meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet. Clubs will be notified of changes no later than Monday before the meet.

**RELAYS:** None

**SAFETY:**

1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
2. No shaving is permitted at the competition site.
3. No glass containers are permitted within the facility.
4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
5. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

**PHOTOGRAPHY AND VIDEO RECORDING:**

Meet Management has the full authority to restrict any and all photography and visual recording at the meet. Photography or video recording (using cameras, video cameras, iPads, cell phones, etc) from the deck is prohibited by all individuals other than participating Coach and Athlete Members unless prior authorization from the Meet Referee or his/her designee has been granted. Flash photography is prohibited during the start of any heat, including whenever any swimmer is stepping up or standing on a block for the purpose of the start of a heat.

Additionally, the following “Non-Camera Zones” shall be enforced:

- Photography or video recording and the use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.
- Photography or video recording (using cameras, video cameras, iPads, cell phones, etc) is not permitted in the area immediately behind the starting blocks at either end of the racing course(s) while they are in use for “race starting purposes” during competition and warm-ups.
- Additional "Non-Camera Zones" may be designated by Meet Management.

Any individual failing to abide by these rules may be ejected from the facility and be subject to a Code of Conduct violation at the discretion of Meet Management.

**RULES:** Current USA Swimming rules will govern all competition.

**TIME TRIALS:** Yes. Time trials may be offered at the discretion of the Meet Referee in accordance with CSI Policy if time allows. Time trials are limited to the events published in this meet announcement (age/distance/stroke). Time Trials will count toward the athlete’s event limitations for the day and meet. If they are offered, only athletes properly entered in one or more events in the meet are eligible for time trials and must be properly entered in the Time Trial. The deadline for Time Trial entries is 30 min prior to the end of each session. The fee for Time Trial entries are \$10.00 for individual events.

**TIMERS, OFFICIALS, OR WORK ASSIGNMENTS:** Teams will be asked to supply timers in relationship to the size of their entry. Swimmers need to provide their own timers/lap counters for Friday evening events. Teams supplying names of parents willing to officiate will have their timing assignments adjusted. Timing assignments will be published no later than Tuesday before the meet.

**DECK ACCESS:** Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

**SCORING:** The meet will not be scored.
