**MEET TYPE:** Sanctioned

MEET CLASSIFICATION: This meet is open to all USA Swimming athletes and clubs.

**MEET FORMAT:** The meet will be swum as Timed-Finals

**SCRATCH PROCEDURES:** All scratch sheets are due to the pool office no later than 20 minutes after the start of warm-up. Failure to deliver a scratch sheet by the deadline will result in the entire team being scratched.

**FACILITY:** Bulkeley High School is a 6 lane, 25 yard pool. The starting end depth is 12 feet and the turn depth is 4 feet. The competition course has not been certified in accordance with 104.2.2C (4). We will be using Colorado Timing system with a multiple line scoreboard along with 2 back up timers. The locker rooms are very ample for all of the swimmers. There are bathrooms for adults on the second floor Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

**DISABLED ACCESS:** Facility is handicapped accessible. Please contact the Meet Director if you need special arrangements.

#### COURSE: SCY

SESSION TIMES: Subject to Change 12/under 9:15 am Warmup 10:30 am Start **WARM-UPS:** CT Swimming Warm-Up Procedures will be in effect. All sessions will use 2 tiers of warm-ups, using 6 lanes, with lanes assigned by team. At the conclusion of those 2 warm-up tiers there will be an additional warm-up period for all teams with lanes 1 and 6 being pace lanes and lanes 2-5 designated as one-way sprints with starts from the blocks. The meet director reserves the right to condense or expand this warm-up format dependent upon meet subscription.

**ELIGIBILITY:** All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete registration procedures. Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck.

**ADAPTED SWIMMING:** Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability prior to competition. Adapted athletes may direct questions to <u>Mark Kinne</u>, Adapted Athlete Committee Chair.

**EVENT INFORMATION:** All Heat Winners will get an award.

ENTRY LIMITATIONS: Swimmers may enter a Maximum of 5 events

ENTRY TIMES: Submit entry times in: SCY. No Times (NT) will not be accepted

**DEADLINES:** <u>Entry deadline is Thursday, April 23, 2015</u>. Please follow instructions for electronic entry submission below. Hard copy should only be sent if electronic entry is not available. Mail hard copy and payment to the entry chairperson: David Laudati at 335 Bloomfield Ave, West Hartford, Ct. 06117. All entries must be legible and must use full names and registration numbers from USA Swimming registration. Entries are accepted on a first come, first served basis. Formal team entry date is determined by the date the electronic entry is received via email and entry fee received by the host team

**CONNECTICUT-ONLY DEADLINE:** CT deadline is Tuesday, April 20<sup>th</sup> 2015. CT clubs meeting this deadline will be entered before out of state clubs. CT clubs meeting this deadline will be entered before out of state clubs.

**ELECTRONIC ENTRIES:** Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at <u>dlaudati@mandelljcc.org</u>. Please check that your team name, address, and contact information are listed correctly in this file.

**ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION**: Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

**ENTRY FEES:** Electronic entries: \$7.00 for individual events; Manual entries: \$10.00 for individual events. No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry.

**PAYMENT INSTRUCTIONS**: Please make checks payable to Mandell JCC and mail to: David Laudati at 335 Bloomfield Ave, West Hartford, Ct. 06117. Payment must be received by Friday April 24<sup>th</sup> 2015.

**CUT PROTOCOL:** Teams will be notified of entry acceptance within 24 hours of entry arrival. Teams whose entries cannot be accepted will be notified as soon as the meet is full, but not later than April 27<sup>th</sup> 2015. If cuts or changes are made, the contact person listed on the entry will be notified.

**RESERVE THE RIGHT TO MAKE CHANGES:** With prior approval from Program Operations and in accordance with CSI Policies, the meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet. Clubs will be notified of changes no later than Monday before the meet.

### **RELAYS:** No

### SAFETY:

- 1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
- 2. No shaving is permitted at the competition site.
- 3. No glass containers are permitted within the facility.
- 4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
- 5. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

# PHOTOGRAPHY AND VIDEO RECORDING:

Meet Management has the full authority to restrict any and all photography and visual recording at the meet. Photography or video recording (using cameras, video cameras, iPads, cell phones, etc) from the deck is prohibited by all individuals other than participating Coach and Athlete Members unless prior authorization from the Meet Referee or his/her designee has been granted. Flash photography is prohibited during the start of any heat, including whenever any swimmer is stepping up or standing on a block for the purpose of the start of a heat.

Additionally, the following "Non-Camera Zones" shall be enforced:

- Photography or video recording and the use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.
- Photography or video recording (using cameras, video cameras, iPads, cell phones, etc.) is not permitted in the area immediately behind the starting blocks at either end of the racing course(s) while they are in use for "race starting purposes" during competition and warm-ups.
- Additional "Non-Camera Zones" may be designated by Meet Management.

Any individual failing to abide by these rules may be ejected from the facility and be subject to a Code of Conduct violation at the discretion of Meet Management.

RULES: Current USA Swimming rules will govern all competition.

# TIME TRIALS: No

**TIMERS, OFFICIALS OR WORK ASSIGNMENTS:** Participating clubs must be notifies of work assignments by the Monday before the meet.

**DECK ACCESS:** Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.
