MEET TYPE: Closed.

MEET DURATION: Full meet with time limits as defined by CT/USA Swimming.

MEET FORMAT: There will be two sessions. The meet will be swum as a Timed-Final.

SCRATCH PROCEDURES: No scratches will be taken. The meet will be pre-seeded.

NO DECK ENTRIES WILL BE ALLOWED

BEFORE ENTERING FACILITY: Anyone entering the YMCA must wear a face covering, stop at the kiosk, answer health questions before entering the YMCA.

FACILITY RULES: Swimmers will enter through the family locker room. All swimmers will be required to wear a face covering while on deck. Face coverings will be worn to the block and can be left on the back of the block while competing. I recommend bringing a zip lock bag. No deck chairs required; all swimmers will be seated on bleachers. Social distancing of 6 feet at all times will be enforced by coaches and lifeguards.

Planned number of individuals on deck: Maximum of 67 3 – COACHES, 48 – ATHLETES, 8 – TIMERS, 4 – OFFICIALS, 2 – LIFEGUARDS, 0 - SPECTATORS, 65 TOTAL Planned number of individuals in spectating area: 0 – no spectators allowed **FACILITY:** The Henry Ziegler Pool at the Darien YMCA is a 6 -lane, 25-yard pool. Water depth at start end is: 10 feet. Water depth at turn end is: 3.5 feet. Select One: The competition course has not been certified in accordance with 104.2.2C(4).

TIMING SYSTEM: Colorado Timing System, in compliance with USA Swimming rules for competition, section 102.24.2.A.

LOCKER ROOMS: Locker rooms are available with limited showers. Changing into or out of swimsuits is prohibited. Best practice is for swimmer to arrive in their suits.

SAFE SPORT POLICIES: The meet will be livestreamed via Zoom, and a secure, password protected link will be sent to families of swimmer entered in the meet the week of the meet.

SESSION TIMES: Subject to Change

Session I – Wednesday 4:45p Warm-up, 5:45p Start Session II – Wednesday 6:45p Warm-up, 7:00p Start

WARM-UPS: CT Swimming Warm-Up Procedures will be in effect. There will be assigned lanes as well as up to two warm-up sessions based on the final number of swimmers entered in the meet. We will observe a maximum of four swimmers per lane for warm-up, and the number of warmup sessions will be based on that number. Swimmers will warm-up only in their practice cohorts, as required by the State of Connecticut.

ELIGIBILITY: Intrasquad meet. Athletes with Flex memberships must not have swum in more than one USA Swimming meet prior to this meet in order to be eligible.

All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. This meet is open to swimmers 9 years of age and older. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete registration procedures. Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck Clubs are reminded that participation of unregistered swimmers and/or coaches will result in a **\$100 fine** per instance, as described in CT Swimming policy for clubs and policy for meet hosts.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water **without the use of the backstroke ledge.** When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

ADULT ATHLETES: All athletes who will be 18 years of age or older on any day of the meet must complete the mandatory Athlete Protection Training prior to competition. Failure to do so will result in the swimmer being scratched from the meet.

ADAPTED SWIMMING: Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary, then the coach or athlete must notify the meet referee of any disability <u>prior</u> to competition. Adapted athletes may direct questions to the <u>Connecticut Swimming office</u>.

EVENT INFORMATION: No Spectators on Deck. A Zoom link will be emailed to parents. Meet will not last more than 2.25 hours.

ENTRY LIMITATIONS: Session I - Swimmer may swim a maximum of 3 events. Session II – Swimmers can enter a maximum of 1 event.

ENTRY TIMES: Submit entry times in: SCY

DEADLINES: Deadline is 11:59p on 3/8/21. All entries through the Piranha Active Network.

ELECTRONIC ENTRIES: See above.

ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION: Only Piranhas are allowed in this meet. No outside teams will be invited or allowed to enter.

ENTRY FEES: None!

OUTREACH ENTRY FEE REIMBURSEMENT: Not necessary.

PAYMENT INSTRUCTIONS: No payment for this meet. It is on us!

CUT PROTOCOL:

If the session is oversubscribed the following protocol will be instituted IN THE ORDER PRESENTED to reduce the timeline to the required length or participation number:

1. The maximum number of events allowed per day may be reduced by one (2).

The host reserves the right to seek approval from Program Operations for additional changes, which may reasonably maximize participation opportunities.

Notification of any cuts or requests for changes must be made to Program Operations as soon as possible by the host. Attending teams will be notified no later than the Monday before the meet.

RESERVE THE RIGHT TO MAKE CHANGES: In accordance with CSI Policies, the meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet. The Meet Referee will seek Program Operations approval for all changes requiring approval. Clubs will be notified of changes no later than Monday before the meet.

RELAYS: No relays.

SAFETY:

- 1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
- 2. No shaving is permitted at the competition site.
- 3. No glass containers are permitted within the facility.
- 4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
- 5. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

SWIMWEAR: Per CT Swimming policy, swimmers 12 years old and younger are not permitted to wear "Tech Suits" at any CT sanctioned or approved meets. "Tech Suits" are defined as a suit that has Bonded Seams, Kinetic Tape, or Meshed Seams. Age is determined on the first date of the meet.

PHOTOGRAPHY AND VIDEO RECORDING: Meet Management has the full authority to restrict any and all photography, audio and visual recording using cameras, video cameras, tablets, cell phones or other electronic devices at a meet.

Photography or video recording from the deck is prohibited by all individuals, other than participating Coaches, unless prior authorization from the Meet Referee or meet referee has been granted.

Under no circumstances is photography or video recording permitted by anyone in the area adjacent to or behind the starting blocks, including spectator stands at deck level, while they are in use for race starting purposes during competition and warm-ups. Flash photography is prohibited during the start of any heat, including whenever any swimmer is stepping up or standing on a block for the purpose of the start of a heat.

Photography or video recording and the use of audio, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Additional "No Camera Zones" may be designated by Meet Management or the meet referee.

If individuals are properly credentialed, not obstructing movement on the deck and abiding by these rules, the following individuals may be allowed by Meet Management and the meet referee with prior authorization if they possess the following:

- Professional photographers with current, official media credentials that are promoting the sport of swimming
- Official team and professional meet photographers that are USA Swimming members, background checked, have signed off on MAAPP and completed Athlete Protection Training
- A participating athlete directly assisting a Coach, for instructional purposes, during an event using the Coach's electronic device

Any individual failing to abide by these rules may be ejected from the facility and be subject to a Code of Conduct violation at the discretion of Meet Management.

DRONES: Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by USA Swimming Vice President of Program Operations.

RULES: Current USA Swimming rules will govern all competition. Amended USA Swimming rules for

TIME TRIALS: No

TIMERS, OFFICIALS OR WORK ASSIGNMENTS: We will need a total of 8 timers. Piranhas will cover all timing and anyone who wishes to officiate please contact the Official's contact listed on the first page of the announcement.

All volunteers will be required to attest to reading and understanding the <u>Minor Athlete Abuse Prevention</u> <u>Policy.</u>

DECK ACCESS: Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

SCORING: The meet will not be scored.

AWARDS: No awards.

CONCESSIONS: The Darien YMCA Little Bite Café will be open for part of the meet.

HOSPITALITY FOR COACHES AND OFFICIALS: A small hospitality will be available to coaches, officials and timers.

MISCELLANEOUS:

PARKING: Parking is available at the YMCA. Overflow parking can be found on Saltbox Lane (the side street next to the church across the street from the Y). **NO PARKING AT THE CHURCH OR ON SEAVIEW AVE OR LIGHTHOUSE ROAD.**

DIRECTIONS:

<u>I-95 Southbound</u>: Exit 11, US 1 (Post Rd.) Darien. Take left at bottom of ramp onto US 1 South (West). Go under I-95. Go through 5 stop lights. The YMCA will be on your left (small sign). If you enter Stamford, you've traveled too far.

<u>I-95 Northbound</u>: Exit 9. Take left at end of ramp. Take right at light onto US 1 North (East). Follow US 1 into Darien. YMCA will be on your right (small sign). If you hit a stop light, in Darien, you've traveled too far.

Merritt Parkway (Route 15): Exit 37, New Canaan & Darien. At the end of ramp, take a right onto CT 124. Follow CT 124 into Darien to intersection with US 1 (Post Rd.). Turn right onto US 1. Go through downtown Darien under RR truss and I-95. Go through 5 stop lights. The YMCA will be on your left (small sign). If you end up in Stamford, you've traveled too far.

Before you travel to the Y

- If you are sick STAY HOME.
 - Err on the side of caution.
 - Anyone who has a temperature 100.4 or over must be fever free for 72 hours before returning to the Y
- Anyone who has traveled within the last 14 days to any of the states on the State of CT Covid States list will not be allowed into the building.
- Must wear face covering.

Entering the YMCA

- Upon entering you will need to stop at a kiosk outside to answer questions about your health.
- Everyone will enter and exit the Y through the same front double slider doors, but there will be directional arrows showing which way is the entry lane and which is the exit lane.
- Anyone who enters the Y MUST sanitize/wash hands upon entry and exit.
- Anyone who enters the Y MUST wear a face covering and keep face covering on while in the facility or have a Doctor's note explaining why you are exempt.
- Anyone who enters the Y MUST maintain 6 feet of social distance at all times except with household family members.

Entering/While on Deck

- Swimmers will enter the pool through the Special Needs/Family locker room and exit through the lobby door.
- Everyone will move around the deck in a counter-clockwise manner, there will be arrows on the pool deck showing direction.
- Face coverings will be worn as long as possible before swimming and put on as soon as possible afterwards.
- Swimmers are permitted to use the All Ages Locker rooms before or after practice.
 - Face coverings MUST be worn at all times in the locker room unless showering.
 - Showering to rinse only, no shampoo or soap allowed. Showers MUST be short and sweet.
 - I encourage swimmers to arrive and leave in their suits.
 - A coach will not be in the locker room to monitor.
- Swim bags will be brought on deck
- Bleachers will available for swimmer seating, no deck chairs
- Always maintain 6 feet of social distance except for siblings and households.
