MEET DURATION: Full meet with time limits as defined by CT/USA Swimming.

MEET FORMAT: The meet will be swum as a Timed-Final

FACILITY: The Larry Hart Pool is an 8 lane 25 meter facility. The competition course has not been certified in accordance with 104.2.2C(4). Water depth at start end is 12 feet. Water depth at turn end is 4 feet. Colorado electronic timing system will be used with results displayed on a state-of-the-art scoreboard. Personal chairs or like furniture are permitted on the pool deck. No electronic audio or visual recording devices, including cell phones, are permitted in changing areas, rest rooms, locker rooms, or pool deck. Deck capacity is 240 people. Spectator viewing area capacity is 140 people.

Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

DISABLED ACCESS: Handicapped Parking may be arranged through the meet director as needed. Locker room and pool deck are handicap accessible. If special assistance is required by athletes, coaches or spectators, please contact the meet director.

WARM-UPS: CT Swimming Warm-Up Procedures will be in effect. Session 1 will use all 8 lanes.

ELIGIBILITY: All USA Swimming clubs and individuals. All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete [registration procedures](#). Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck. Clubs are reminded that participation of unregistered swimmers and/or coaches will result in a **\$100 fine** per instance, as described in CT Swimming meet policies:

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water **without the use of the backstroke ledge**. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

ADAPTED SWIMMING: Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability prior to competition. ENTRY LIMITATIONS: Timed Final, maximum 5 individual events and 2 relays

All entries must be legible and must use full names and registration numbers from USA Swimming registration. Email receipt of entry will determine the date an entry is received.

CONNECTICUT-ONLY DEADLINE: CT deadline is April 22, 2019. Email receipt of entry will determine the date an entry is received. CT clubs meeting this deadline will be entered before out of state clubs.

ELECTRONIC ENTRIES: Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at coachlyman@hotmail.com. Please check that your team name, address, and contact information are listed

correctly in this file. Please make checks payable to MRSC and mail to: Jen Lyman, 4B Hamre Lane, CT, 06405. Payment must be received by 06/05/19.

ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION: Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

ENTRY FEES: Electronic entries: \$8.00 for individual events, \$12.00 for relays. Manual entries: \$12.00 for individual events, \$16.00 for relays. No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry.

CUT PROTOCOL:

If the session is oversubscribed the following protocol will be instituted IN THE ORDER PRESENTED to reduce the timeline to the required length or participation number:

1. All relays, if planned, will be eliminated.
2. The maximum number of events allowed per day may be reduced by one (1).
3. Visiting teams may be cut based on the date/time of the receipt of the final paid entry. If teams are cut, the host reserves the right to offer the available partial entry to the cut teams in the order that entries were received in order to fill the meet.

The host reserves the right to seek approval from Program Operations for additional changes, which may reasonably maximize participation opportunities.

Notification of any cuts or requests for changes must be made to Program Operations as soon as possible by the host. Attending teams will be notified no later than the Monday before the meet.

NOTE: If the host is required to institute the published cut protocol above. All accepted entries at the time that the cut protocol is instituted may be considered final by the host for the purposes of financial responsibility. (i.e. Teams submitting "placeholder" entries will be required to pay for the entries if the cut protocol is required).

RESERVE THE RIGHT TO MAKE CHANGES: In accordance with CSI Policies, the meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet. The Meet Referee will seek Program Operations approval for all changes requiring approval. Clubs will be notified of changes no later than Monday before the meet.

RELAYS: Yes. There are no relay limitations. All relay swimmers must be officially entered in the meet.

SAFETY:

1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
2. No shaving is permitted at the competition site.

3. No glass containers are permitted within the facility.
4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
5. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

PHOTOGRAPHY AND VIDEO RECORDING:

Meet Management has the full authority to restrict any and all photography and visual recording at the meet. Photography or video recording (using cameras, video cameras, iPads, cell phones, etc) from the deck is prohibited by all individuals other than participating Coach and Athlete Members unless prior authorization from the Meet Referee or his/her designee has been granted. Flash photography is prohibited during the start of any heat, including whenever any swimmer is stepping up or standing on a block for the purpose of the start of a heat.

Additionally, the following "Non-Camera Zones" shall be enforced:

- Photography or video recording and the use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.
- Photography or video recording (using cameras, video cameras, iPads, cell phones, etc) is not permitted in the area immediately behind the starting blocks at either end of the racing course(s) while they are in use for "race starting purposes" during competition and warm-ups.
- Additional "Non-Camera Zones" may be designated by Meet Management.

Any individual failing to abide by these rules may be ejected from the facility and be subject to a Code of Conduct violation at the discretion of Meet Management.

DRONES: Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Program & Events Committee Chair or designee.

RULES: Current USA Swimming rules will govern all competition.

TIME TRIALS: No

TIMERS, OFFICIALS OR WORK ASSIGNMENTS: Participating clubs will be notified of work assignments by the Monday before the meet.

DECK ACCESS: Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

SCORING: The meet will not be scored.

AWARDS: Yes. Swimmers must compete in all five individual events to be eligible for an overall award to the top 8 finishers in the following age groups 8/U, 9-10, 11-12. This will be determined by adding all 5 times together.

PARKING:

There is parking near the Larry Hart pool entrance and at the Ice Arena. Please respect handicapped parking areas, and no parking areas. Please do not park on the street. Choate Rosemary Hall Security patrols the area and can offer alternative parking areas.

DIRECTIONS:

From The North : I-91 Take Exit 14 and turn right onto East Center Street. Go straight through four sets of lights. At the fifth light (Elm Street intersection), take a right. At the first stop sign (Christian Street), take a right for Johnson Athletic Center, and Larry Hart Pool. Turn right into the first parking lot. If additional events are going on, parking is also available at the Paul Mellon Arts Center.

From the South : I-91 Take Exit 14 and turn left onto Woodhouse Avenue (Rt. 150) At the second light, take a left onto Center St. At the third light (Elm Street intersection), take a right. The first stop sign is Christian Street, take a right for the Johnson Athletic Center, and the Paul Mellon Arts Center. Paul Mellon Arts Center and Johnson Athletic Center — first parking lot on the right.

From the North and South: Wilbur Cross Parkway (Rt. 15)

Take Exit 64 and turn right onto Quinnipiac St. Bear left at Wallace Park and cross over the R.R. tracks. Go straight through light (Quinnipiac becomes Center St. at this intersection). Turn left at second light (at top of hill) onto North Main St. Turn right at first stop sign onto Christian Street. Go straight through stop sign at bottom of hill (North Elm Street intersection). Look for Johnson Athletic Center; Larry Hart Pool.
