POOL EMERGENCY NUMBER: There is no incoming phone service at the Walsh Intermediate School pool.

SANCTIONED OR APPROVED: Sanctioned

MEET DURATION: Mini meet with all sessions timed to three hours or less before scratches.

MEET FORMAT: All 8 & Under and 9/10 events will be swum as Timed-Finals. 11/12 events will be Prelim-Final format except for the 500 Freestyle which will be Timed-Final. The fastest 12 swimmers at prelims will qualify for the A and B Finals.

SCRATCH PROCEDURES: Coaches will receive scratch sheets at the start of each session and are expected to submit scratches 20 minutes after the start of warm-up. Swimmers who fail to appear for their assigned heat in a timed-final event or in the preliminary heats will be disqualified from that event. There will be no further penalty.

Failure to Compete in Finals: Any swimmer qualifying for any heat of finals who fails to compete and who has not been scratched will be barred from all further competition in the meet. A declared false start or deliberate delay of meet is not permitted and will be regarded as a failure to compete. **Exceptions for Failure to Compete in Finals:** No penalty shall apply for failure to compete in finals if: 1. The Referee is notified in the event of injury of illness and accepts the proof thereof. 2. A swimmer qualifying for a final heat based on the results and preliminarily notifies the announcer within 30 minutes after the announcement of qualifiers that he may not intend to compete and confirms his final intentions within 30 minutes following his last individual preliminary event. 3. It is determined by the Referee that failure to compete is caused by circumstances beyond the control of the swimmer.

FACILITY: The Walsh Intermediate School Pool is a 6-lane, 25-yard pool. Water depth at start end is 10.5 feet. Water depth at turn end is 4 feet. The competition course has not been certified in accordance with 104.2.2C(4). The meet will be run using Colorado timing Systems. Spectator seating capacity is 220 persons.

Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

DISABLED ACCESS: There are designated handicap parking spaces in the main school parking lot. The school, pool and spectator areas are wheel-chair accessible, but the pool locker rooms are NOT. Disabled swimmers who require assistance should email Susan Lecza (suelecza@gmail.com) prior to the meet to make arrangements for access to alternative changing areas.

WARM-UPS: CT Swimming Warm-Up Procedures will be in effect. Warm-up assignments will be made by team based on the size of the entry. 11/12 and 9/10 swimmers will have 20 minutes of general warm-up followed by 10 minutes of one-way sprints. 8 & under swimmers will have 15 minutes of general warm-up followed by 10 minutes of one-way sprints. Teams will be notified of the final warm-up schedule by Monday January 14.

ELIGIBILITY: All USA Swimming clubs and individuals.

All athletes must be current athlete members of USA Swimming. Age on the first day of the meet shall determine the swimmer's age and age group for the meet. Any swimmer, who is entered and is unregistered, will be scratched from the meet until registration is completed. See CT Swimming athlete [registration procedures](#). Registrations will not be processed at the meet. All coaches must present a valid USA Swimming coach card to the Meet Director prior to the commencement of any sanctioned swim meet, and must have this card with them while on deck. Clubs are reminded that participation of unregistered swimmers and/or coaches will result in a **\$100 fine** per instance, as described in CT Swimming meet policies:

ADAPTED SWIMMING: Any current athlete members of USA Swimming with a disability as defined by USA Swimming Rules and Regulations may enter this meet. If modifications to USA Swimming rules are necessary then the coach or athlete must notify the meet referee of any disability prior to competition. Adapted athletes may direct questions to the [Connecticut Swimming office](#).

ENTRY LIMITATIONS: Swimmers may enter a total of 7 individual events for the meet (but not more than 3 per day) and 2 relay events.

ENTRY TIMES: Submit entry times in [SCY](#).

DEADLINES: Entry deadline is Tuesday January 8, 2019. Mail hardcopy and payment to the entry chairperson: Sue Lecza, 16 Beechwood Road, Branford, CT, 06405. All entries must be legible and must use

full names and registration numbers from USA Swimming registration. Entries will be considered received on the date the electronic entry file is received by the Entry Chair or the date the paper entry is received.

ELECTRONIC ENTRIES: Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format may be emailed as an attachment to the entry chair at suelecza@gmail.com. Please check that your team name, address, and contact information are listed correctly in this file. Payments are due prior to the start of the meet on Friday January 18th.

ENTRIES FROM ATHLETES WITH NO CLUB AFFILIATION: Athletes entering this meet independent of a USA Swimming club or coach shall: 1.) be under the supervision of a USA Swimming coach for the duration of the meet. It is the swimmer's responsibility to make arrangements with a USA Swimming member coach prior to the meet. Athletes unaccompanied by a USA Swimming coach will not be permitted on deck. Please contact the Meet Director for assistance. 2) be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. The name of the USA Swimming member coach supervising the athlete and racing certification should be submitted to the Meet Director with the entry.

ENTRY FEES: Electronic entries: \$9.00 for individual events and \$15.00 for relays. Manual entries: \$9.00 for individual events and \$15.00 for relays. No refunds will be given for entries that are accepted, or for entries that are rejected due to improper entry.

CUT PROTOCOL:

If the session is oversubscribed the following protocol will be instituted IN THE ORDER PRESENTED to reduce the timeline to the required length or participation number:

1. The Friday Evening events (11/12 500Y Freestyle and 9/10 200Y Individual Medley) may be heat limited to the first 4 heats of entries per gender in the order they were received.
2. Visiting teams may be cut based on the date/time of the receipt of the final paid entry. If teams are cut, the host reserves the right to offer the available partial entry to the cut teams in the order that entries were received in order to fill the meet.

The host reserves the right to seek approval from Program Operations for additional changes, which may reasonably maximize participation opportunities.

Notification of any cuts or requests for changes must be made to Program Operations as soon as possible by the host. Attending teams will be notified no later than the Monday before the meet.

NOTE: If the host is required to institute the published cut protocol above. All accepted entries at the time that the cut protocol is instituted may be considered final by the host for the purposes of financial responsibility. (i.e. Teams submitting "placeholder" entries will be required to pay for the entries if the cut protocol is required).

RESERVE THE RIGHT TO MAKE CHANGES: In accordance with CSI Policies, the meet referee reserves the right to make any adjustments to the provisions of the meet announcement deemed necessary to ensure the fair and efficient running of the meet. The Meet Referee will seek Program Operations approval for all changes requiring approval. Clubs will be notified of changes no later than Monday before the meet.

RELAYS: Yes. There are no limitations to the number of relays a team may enter. All relay swimmers must be officially entered in the meet.

SAFETY:

1. Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
2. No shaving is permitted at the competition site.
3. No glass containers are permitted within the facility.
4. Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
5. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

PHOTOGRAPHY AND VIDEO RECORDING:

Meet Management has the full authority to restrict any and all photography and visual recording at the meet. Photography or video recording (using cameras, video cameras, iPads, cell phones, etc) from the deck is prohibited by all individuals other than participating Coach and Athlete Members unless prior authorization from the Meet Referee or his/her designee has been granted. Flash photography is prohibited during the start of any heat, including whenever any swimmer is stepping up or standing on a block for the purpose of the start of a heat.

Additionally, the following "Non-Camera Zones" shall be enforced:

- Photography or video recording and the use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.
- Photography or video recording (using cameras, video cameras, iPads, cell phones, etc) is not permitted in the area immediately behind the starting blocks at either end of the racing course(s) while they are in use for "race starting purposes" during competition and warm-ups.
- Additional "Non-Camera Zones" may be designated by Meet Management.

Any individual failing to abide by these rules may be ejected from the facility and be subject to a Code of Conduct violation at the discretion of Meet Management.

DRONES: Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the USA Swimming Vice President of Program Operations.

RULES: Current USA Swimming rules will govern all competition.

TIME TRIALS: No

TIMERS, OFFICIALS OR WORK ASSIGNMENTS: Teams will be required to provide timers in proportion to the size of their entry. Swimmers in the Friday Evening events (9/10 200 IM and 11/12 500 Free) will be expected to provide their own timer. Participating clubs will be notified of work assignments by Monday January 14, 2019.

DECK ACCESS: Only athletes, coaches, officials, and official meet staff actively participating in the meet are permitted on the pool deck.

SCORING: The meet will not be scored.

AWARDS: Yes. Trophies will be awarded to the top 6 finishers in each individual event. Medals will be awarded to the top 3 finishers in relay events. Ribbons will be awarded to swimmers finishing 7th to 12th in

individual events and 4th to 6th in relay events. Awards will be available for pick-up by coaches at the conclusion of the meet.

HOSPITALITY FOR COACHES AND OFFICIALS: Yes

PARKING: Parking is available in the marked lots in front and to the right side of the school. Any cars parked in the circular driveway in front of the school will be ticketed and towed.
